# No. 115.

An Act to authorise the Construction of a Tank, Well, and other works, for the purpose of extending the Supply of Water to Mitcham.

[Assented to, 30th November, 1878.]

WHEREAS it is desirable to authorise the construction of a Preamble. tank, well, and other works for the purpose of extending the supply of water to the District of Mitcham, according as the said district is defined in the Schedule hereto: And whereas plans and sections showing the source of supply and the said tank, well, and other works, and the direction of the main and branch pipes, and the streets and grounds through which they are to be laid, and also books of reference containing the names of the owners and occupiers, or reputed owners or occupiers (so far as known), of any private lands on which the said tank, well, or other works will be constructed, or through which the same will pass, have been deposited in the office of the Surveyor-General, at Adelaide—Be it therefore Enacted by the Governor of the Province of South Australia, with the advice and consent of the Legislative Council and House of Assembly of the said province in this present Parliament assembled, as follows:

1. The Commissioner of Waterworks may construct, out of any Commissioner of moneys which have been or hereafter may be voted by Parliament Waterworks may construct tank, well, and for such purpose, the tank, well, and other works, in accordance other works. with the said plans and sections deposited in the office of the Surveyor-General, at Adelaide.

2. If any error, omission, misstatement, or wrong description Errors and omission shall have been made of any lands or streams, or of the owners in plans, &c., may be corrected by Justices,

or occupiers, or reputed owners or occupiers, of any lands or streams delineated or shown on the said plans or sections, or described in the books of reference deposited as aforesaid, the Commissioner of Waterworks, after giving ten days' notice to the owners or occupiers, or reputed owners or occupiers, of the lands and streams affected, or likely to be affected, by the correction of such error, omission, misstatement, or wrong description, may apply to two justices to correct the same; and, if it shall appear to such justices that it is expedient and not unjust to correct such error, omission, misstatement, or wrong description, they shall give the said Commissioner a certificate in such form as they shall think proper, and shall in such certificate state the particulars of any such error, omission, misstatement, or wrong description; and such certificate, with the documents to which it refers, shall be deposited with the other documents to which they refer, in the office of the Surveyor-General, and thereupon such plans, sections, or book of reference shall be deemed to be corrected according to such certificate, and the said Commissioner may make, complete, extend, and maintain the works hereby authorised, in accordance with such certificate, as if such error, omission, misstatement, or wrong description had not been made.

Surveyor-General to receive plans and allow inspection.

3. The Surveyor-General shall keep the said plans and sections, and books of reference, and all other documents deposited with him, for the purposes of this Act, and shall allow all persons interested to inspect any of the documents aforesaid, and to make copies and extracts of and from the same.

Interpretation.

4. In the construction of, and for the purposes of this Act and "The Adelaide City, Port, and Suburban Waterworks Act, 1874," when not inconsistent with the context, the expression, the "undertaking" shall, in addition to the meaning assigned thereto by the said "The Adelaide City, Port, and Suburban Waterworks Act, 1874," mean and include the high-level reservoir and other works hereby authorised to be constructed; the expression, "lands and streams" shall, in addition to the meaning assigned thereto by the said Act, mean and include the land and streams of water hereby authorised to be taken or used for the purposes hereof, and the expression "water area" shall, in addition to the meaning assigned thereto by the said Act, mean and include the district of Mitcham, according as the same is defined in the schedule hereto.

Short title.

5. This Act may be cited for all purposes as "The Mitcham Waterworks Act, 1878."

Incorporation.

6. Except so far as the same is inconsistent with or altered by this Act, this Act and "The Adelaide City, Port, and Suburban Waterworks Act," shall be incorporated and read as one Act.

## Mitcham Waterworks Act.—1878.

#### THE SCHEDULE REFERRED TO.

#### DISTRICT OF MITCHAM.

Comprising the whole of preliminary sections Nos. 245, 246, 248, 232, 233; sections 247, 262, and part of section 884, Hundred of Adelaide, bounded as follows:—

Commencing at the south-western corner of preliminary section 234; thence easterly along the southern boundary of the said section to the eastern side of the road on the east side of the said section, thence northerly along the eastern side of the said road to the south-western corner of section 244; thence easterly along the southern boundary of the said section to its south-eastern corner; thence southerly along the western boundary of section 249 to the south-western corner thereof; thence easterly along the southern boundary of the said section 249 to the southeastern corner thereof; thence southerly along the western side of the road on the west side of sections 892 and 891, across the said road and along the western boundary of section 1094, to a point therein distant 1,660 links from the north-western corner thereof; thence westerly to the south-eastern corner of section 884; thence along the southern boundary of the last-mentioned section for 1203 links to the intersection therewith of the road running through the same section; thence north-westerly along the north-eastern side of the said road to its intersection with the south-western boundary of the same section, and along the said boundary thereof to a point due east of the northern corner of section 247B; thence across the road to such corner, and south-westerly along the north-western boundary of the last-mentioned section to the eastern corner of section 100; thence westerly along the northern boundary of the last-mentioned section to the western side of the road on the west side of such section; thence southerly along the western side of such road to its intersection with the northern side of the road, on the north side of section 1075; thence westerly along the northern side of such last-mentioned road to the south eastern corner of section 259; thence northerly along the eastern boundaries of sections 259, 258, 257, 256, and portion of section 255 to the point of commencement according as the said sections are delineated in the public maps of the said province.
