An Act to authorise portion of certain Park Lands at Port Augusta West to be Surveyed and Sold as Town Lands.

[Assented to, November 17th, 1882.]

WHEREAS it is expedient to authorise portion of certain park Preamble. lands at Port Augusta West to be surveyed, delineated, and sold as town lands, and to make necessary roads and reserves for public purposes—Be it therefore Enacted by the Governor of the Province of South Australia, with the advice and consent of the Legislative Council and House of Assembly of the said province, in this present Parliament assembled, as follows:

1. Act No. 165 of 1880, intituled "An Act to authorise the Repeal of Act No. 165 granting to the Minister Controlling Education of portion of of 1880. certain Park Lands at Port Augusta West," is hereby repealed.

2. From and after the passing of this Act all that portion of the Lands described in park lands adjoining the Township of Port Augusta West, defined Schedule may be surveyed and sold. in the Schedule hereto, and containing one hundred acres or thereabouts, shall cease to be reserved and dedicated as a place for the recreation and amusement of the inhabitants of the Township of Port Augusta West, and may be surveyed, delineated, and sold under the provisions of the "Crown Lands Consolidation Act" as town lands, subject to necessary reserves for roads and other public purposes.

In the name and on behalf of Her Majesty, I hereby assent to this Bill.

Port Augusta Park Lands Sale Act.-1882.

THE SCHEDULE REFERRED TO

Commencing at a point eleven chains south-east of the south-eastern boundary of section 174, and 1,156 links north-east of the north-eastern boundary of section 135, suburban to Port Augusta West; thence south-easterly by a line north-east of and parallel to the north-eastern boundaries of sections 134 and 109 to high-watermark on the sea-coast; thence easterly along the sea-coast to the south-western boundary of the Township of Port August West; thence north-westerly and north-easterly along boundaries of said township to the west side of Loudon's Road; thence north-westerly along said side of road, and north-easterly along the north-western boundary of said township to its north corner; thence south-easterly along its north-eastern boundary to high-watermark on the sea-coast; thence north-easterly along high-water mark for about eleven chains; thence north-westerly by a line eight chains north-east of and parallel to the north-eastern boundary of said township for about twenty-three chains; thence south-westerly at right angles by a line eight chains north-west of and parallel to the north-western boundary of township aforesaid for a distance of 4,744 links to the point of commencement.
