No. 4 of 1953.

An Act to authorize the Treasurer to borrow and expend money for public works and purposes, and to enact other provisions incidental thereto.

[Assented to 3rd September, 1953.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

- 1. This Act may be cited as the "Public Purposes Loan Short title. Act, 1953".
 - 2. In this Act, unless the context otherwise requires—

Interpretation.

- "the financial agreement" means the Financial Agreement made between the Commonwealth and all the States and set out in the schedule at the end of the Amending Financial Agreement Act, 1944;
- "the loan fund" means the money mentioned in section 3 of this Act;
- "schedule" means schedule to this Act.
- 3. For the purposes of this Act the loan fund shall consist The loan fund. of—
 - (a) any money standing to the credit of the loan fund account in the Treasury at the commencement of this Act;
 - (b) all money received after the commencement of this Act by the Treasurer in repayment of advances made, or money expended, out of money borrowed under any Act;

- (c) all surplus revenue applied after the commencement of this Act to loan accounts in accordance with section 30 of the Public Finance Act, 1936-1949;
- (d) the money borrowed under this Act.

Power to borrow.

4. The Treasurer may arrange for the sum of twenty-five million one hundred and eighteen thousand pounds to be borrowed on behalf of the State in accordance with the financial agreement.

Issue and application of money from loan fund.

- 5. (1) There may be issued out of the loan fund any sums not exceeding twenty-seven million six hundred and eighteen thousand pounds.
- (2) The sums so issued shall be applied for the purposes mentioned in the first schedule.
- (3) If the amount mentioned in any line of the first schedule as the estimated expenditure for the work or purpose mentioned in that line is insufficient for that work or purpose, the Treasurer may issue additional money from the loan fund for that work or purpose but so that the total amount issued under this Act from the loan fund during the financial year 1953-1954 for works and purposes mentioned in the first schedule shall not exceed twenty-seven million six hundred and eighteen thousand pounds.

Loans to recoup money advanced under Public Finance Act.

- 6. (1) The Treasurer may, in addition to the other amounts authorized by this Act to be borrowed, arrange for the borrowing on behalf of the State in accordance with the financial agreement, of a sum of three thousand pounds, being the amount advanced by the Treasurer pursuant to subsection (2) of section 32b of the Public Finance Act, 1936-1949.
- (2) There may be issued out of the loan fund a further sum not exceeding three thousand pounds.
- (3) The sums so issued shall be applied for the purposes mentioned in the second schedule.

Flotation expenses.

7. The Treasurer may—

(a) in addition to the other amounts authorized by this Act to be borrowed, arrange for the borrowing on behalf of the State in accordance with the financial agreement of a sum equal to the discounts, charges and expenses incurred in connection with the borrowing of money under this Act;

- (b) issue a sum equal to those discounts, charges and expenses out of the loan fund, and apply the sum so issued in payment of those discounts, charges and expenses.
- 8. If the money in the loan fund is at any time insufficient for the purpose of carrying out the works and purposes mentioned in the first schedule the Treasurer may use other money in his hands for those purposes, but any money so used shall be repaid from the loan fund as soon as there is sufficient money in that fund to make the repayment.

9. (1) If, during the financial year 1953-1954, the Treasurer is of opinion that additional loan money may be available sums if further for the State, he may arrange for the borrowing, on behalf loan money available. of the State in accordance with the financial agreement, of an additional sum not exceeding four million one hundred and ninety-thousand pounds.

- (2) There may be issued out of the loan fund, in addition to the sums mentioned in the preceding sections of this Act, any further sums not exceeding the amount borrowed under this section.
- (3) Any sum so issued shall be applied to meet expenditure on all or any of the loan undertakings mentioned in the first schedule, additional to the amount of the estimated expenditure indicated in that schedule, but so that the total amount spent on those undertakings during the financial year 1953-1954 shall not exceed thirty-one million eight hundred and eight thousand pounds.

The amount to be allocated out of any sum so issued to each loan undertaking shall be determined by the Treasurer.

10. (1) The Treasurer may arrange to borrow, during the power to period between the 30th June, 1954, and the commencement apply ion of the Act authorizing the raising and expenditure of loan money in 1954-1955 for the financial year 1954-1955, on behalf of the State in accordance with the financial agreement any sums not exceeding seven million pounds.

- (2) There may be issued out of the loan fund during the said period any sums not exceeding seven million pounds.
- (3) Any sum so issued shall be applied to meet expenditure on all or any of the loan undertakings mentioned in the first schedule during the said period and the amount to be allocated to each such undertaking shall be determined by the Treasurer.

Duration of Act.

11. The authority to borrow money and to issue and apply money from the loan fund, given by the provisions of this Act, other than sections 7, 8 and 10 shall cease on the thirtieth day of June, 1954.

Authority to expend money received from Commonwealth.

- 12. (1) All money advanced to the State pursuant to the Commonwealth and State Housing Agreement shall be credited to a special account in the books of the Treasurer, and the Treasurer shall out of the money so credited issue and pay to the South Australian Housing Trust such sums as are required for purposes specified in the said Agreement.
- (2) All money received by the State from the Commonwealth by way of grants under the Commonwealth Aid Roads Act, 1950, shall be paid to a special account in the books of the Treasurer, and the Treasurer shall on the request of the Minister of Local Government issue and pay out of the money so credited such sums as are required for purposes specified in the said Act.
- (3) The Treasurer shall be deemed to have had authority during the period of three financial years ended on the thirtieth day of June, nineteen hundred and fifty-three, to—
 - (a) credit to a special account in the Treasury all money received from the Commonwealth by way of grants under the Commonwealth Aid Roads Act, 1950;
 - (b) to issue and apply the money so credited for purposes specified in the said Act.

Commencement of Act.

13. This Act shall be deemed to have come into operation on the first day of July, nineteen hundred and fifty-three.
