## No. 28 of 1970

An Act to amend the Public Works Standing Committee Act, 1927-1955, as amended.

[Assented to 5th November, 1970]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

Short titles.

- 1. (1) This Act may be cited as the "Public Works Standing Committee Act Amendment Act, 1970".
- (2) The Public Works Standing Committee Act, 1927-1955, as amended by the Statutes Amendment (Public Salaries) Act, 1955, by the Statutes Amendment (Public Salaries) Act, 1960, and by this Act, may be cited as the "Public Works Standing Committee Act, 1927-1970".
- (3) The Public Works Standing Committee Act, 1927-1955, as amended by the Statutes Amendment (Public Salaries) Act, 1955, and the Statutes Amendment (Public Salaries) Act, 1960, is hereinafter referred to as "the principal Act".

Amendment of principal Act, s. 11—
Salaries of chairman and members of committee.

- 2. Section 11 of the principal Act is amended—
  - (a) by striking out from subsection (1) the passage "seven hundred and fifty pounds" and inserting in lieu thereof the passage "one thousand five hundred dollars";

and

(b) by striking out from subsection (2) the passage "five hundred pounds" and inserting in lieu thereof the passage "one thousand dollars".

3. Section 21 of the principal Act is amended by striking out Amendment of from subsection (1) the passage "fifty pounds" and inserting in lieu s. 21 thereof the passage "one hundred dollars".

Powers of committee in respect of witnesses.

- 4. Section 25 of the principal Act is amended—
  - (a) by striking out the passage "first day of July, nineteen hundred and twenty-eight" first occurring in subsection proposals f (1) and inserting in lieu thereof the passage "commencement of the Public Works Standing Committee Act Amendment Act, 1970":

Amendment of principal Act,

Duty to submit works to committee.

- (b) by striking out from paragraph (a) and from paragraph (b) of subsection (1) the passage "one hundred thousand pounds" and inserting in lieu thereof in each case the passage "three hundred thousand dollars";
- (c) by striking out the proviso to subsection (1); and
- (d) by inserting after subsection (4) the following subsection:—
  - (5) The provisions of this section as in force immediately before the commencement of the Public Works Standing Committee Act Amendment Act, 1970, shall apply to and in relation to any proposed public works referred to the committee before such commencement.
- 5. Section 25a of the principal Act is amended by striking out Amendment of the passage "one hundred thousand pounds" and inserting in lieu s. 25athereof the passage "three hundred thousand dollars".

Operation of s. 25 during time of war.

6. Section 26 of the principal Act is amended by striking out the Amendment of passage "the next preceding section" at the end thereof and inserting s. 26 in lieu thereof the passage "section 25 of this Act".

Power to refer any matter involving expenditure of public moneys.
