An Act to amend The Flinders University of South Australia Act 1966, the Ombudsman Act 1972, the University of Adelaide Act 1971 and the University of South Australia Act 1990.

[Assented to 2 December 1999]

The Parliament of South Australia enacts as follows:

**PART 1
PRELIMINARY**

Short title

1. This Act may be cited as the *Statutes Amendment (Universities) Act 1999*.

Commencement

2. This Act will come into operation on a day to be fixed by proclamation.

Interpretation

3. A reference in this Act to the principal Act is a reference to the Act referred to in the heading to the Part in which the reference occurs.

Repeal of s. 24

4. Section 24 of the principal Act is repealed.

**PART 3
AMENDMENT OF THE OMBUDSMAN ACT 1972**

Amendment of s. 3—Interpretation

5. Section 3 of the principal Act is amended—

(a) by inserting after paragraph (a) of the definition of "authority" in subsection (1) the following paragraph:

(ab) the Council of The Flinders University of South Australia;;

(b) by inserting after paragraph (b) of the definition of "authority" in subsection (1) the following paragraph:

(baa) the Council of the University of South Australia;.

**PART 4
AMENDMENT OF THE UNIVERSITY OF ADELAIDE ACT 1971**

Repeal of s. 20

6. Section 20 of the principal Act is repealed.

**PART 5
AMENDMENT OF THE UNIVERSITY OF SOUTH AUSTRALIA 1990**

Repeal of s. 23

7. Section 23 of the principal Act is repealed.
