An Act to amend the Adelaide Festival Centre Trust Act, 1971, the Constitution Act, 1934, the Electricity Trust of South Australia Act, 1946, the Hairdressers Registration Act, 1939, the Opticians Act, 1920, the Pipelines Authority Act, 1967, the State Government Insurance Commission Act, 1970, the State Theatre Company of South Australia Act, 1972, The State Opera of South Australia Act, 1976, and the West Beach Recreation Reserve Act, 1954.

[Assented to 9 April 1987]

The Parliament of South Australia enacts as follows:

Short title

1. This Act may be cited as the "Statutes Amendment (Finance and Audit) Act, 1987".

Commencement.

2. This Act will come into operation on a day to be fixed by proclamation.

Amendment of Adelaide Festival Centre Trust Act, 1971.

- 3. The Adelaide Festival Centre Trust Act, 1971, is amended by striking out subsections (2) and (3) of section 25 and substituting the following subsection:
 - (2) The Auditor-General must, in respect of each financial year of the Trust, audit the accounts of the Trust.

Amendment of Constitution Act, 1934.

- 4. The Constitution Act, 1934, is amended—
 - (a) by striking out from section 71 "any warrant for the payment of money, or";

and

(b) by striking out from section 71 "warrant" second occurring.

Amendment of Electricity Trust of South Australia Act, 1946.

- 5. The Electricity Trust of South Australia Act, 1946, is amended by striking out subsection (1) of section 24 and substituting the following subsection:
 - (1) The Auditor-General must, in respect of each financial year of the trust, audit the accounts of the trust.

6. The Hairdressers Registration Act, 1939, is amended by striking out
Amendment of Hairdressers Registration Act, 1939, is absoluted by striking out Amendment of Hairdressers Registration Act, 1939. subsection (2) of section 15 and substituting the following subsection:

- (2) The Auditor-General must, in respect of each financial year of the board, audit the accounts of the board.
- 7. The Opticians Act, 1920, is amended by striking out subsection (3) Amendment of Opticians Act. 1920.

 Amendment of Opticians Act. 1920. of section 41 and substituting the following subsection:

- (3) The Auditor-General must, in respect of each financial year of the board, audit the accounts of the board.
- 8. The Pipelines Authority Act, 1967, is amended by striking out sub- Amendment of sections (4) and (5) of section 16 and substituting the following subsections: Authority Act.

- (4) The Auditor-General must, in respect of each financial year of the Authority, audit the accounts of the Authority.
- (5) The Minister must cause the report of the Authority referred to in subsection (1) to be laid before both Houses of Parliament as soon as practicable after the Minister has received that report.
- 9. The State Government Insurance Commission Act, 1970, is Amendment of State Government Insurance Commission Act. 1970. amended-

- (a) by striking out subsection (2) of section 19 and substituting the following subsection:
 - (2) The Auditor-General must, in respect of each financial year of the Commission, audit the accounts of the Commission.;

and

- (b) by striking out subsection (4) of section 19.
- 10. The State Theatre Company of South Australia Act, 1972, is amended Amendment of State Theatre by striking out subsections (2) and (3) of section 26 and substituting the Company of South Australia following subsection:

- (2) The Auditor-General must, in respect of each financial year of the Company, audit the accounts of the Company.
- 11. The State Opera of South Australia Act, 1976, is amended by Amendment of The State Opera striking out subsections (2) and (3) of section 23 and substituting the of South Australia Act, 1976. following subsection:

- (2) The Auditor-General must, in respect of each financial year of The State Opera, audit the accounts of The State Opera.
- 12. The West Beach Recreation Reserve Act, 1954, is amended by Amendment of Striking out subsections (2), (3) and (4) of section 14 and substituting the Recreation Reserve Act, 1954, is amended by Amendment of Striking out subsections (2), (3) and (4) of section 14 and substituting the Recreation following subsection:

Reserve Act. 1954.

(2) The Auditor-General must, in respect of each financial year of the trust, audit the accounts of the trust.
