An Act to amend the South Australian Meat Corporation Act, 1936-1972.

[Assented to 11th April, 1974]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

Short titles.

- 1. (1) This Act may be cited as the "South Australian Meat Corporation Act Amendment Act, 1974".
- (2) The South Australian Meat Corporation Act, 1936-1972, is hereinafter referred to as "the principal Act".
- (3) The principal Act, as amended by this Act, may be cited as the "South Australian Meat Corporation Act, 1936-1974".

Amendment of principal Act, s. 3—. Interpretation.

2. Section 3 of the principal Act is amended by inserting in the definition of "stock" in subsection (1) after the passage "goats," the passage "buffaloes,".

Amendment of principal Act, s. 7—
Metropolitan abattoirs area.

- 3. Section 7 of the principal Act is amended by striking out subsection (1) and inserting in lieu thereof the following subsection:—
  - (1) The metropolitan abattoirs area shall be the area comprising—
    - (a) the municipalities of Adelaide, Brighton, Burnside, Campbelltown, Elizabeth, Enfield, Glenelg, Henley and Grange, Hindmarsh, Kensington and Norwood, Mitcham, Port Adelaide, Prospect, St. Peters, Salisbury, Thebarton, Unley, Walkerville, West Torrens and Woodville;
    - (b) the Garden Suburb;

and

(c) that portion of the municipality of Marion north and northeast of the following boundary:—commencing at a point on the western boundary of the municipality being the south-western corner of section 185, hundred of Noarlunga; thence easterly along the southern boundaries of sections 185 and 139 and portion of the southern boundary of section 122 of that hundred to the eastern boundary of the municipality.

4. Section 30 of the principal Act is amended by inserting in paragraph (c) Amendment of principal Act, the passage "Superannuation Act. 1969. as amended" the passage ", or 18.30 after the passage "Superannuation Act, 1969, as amended" the passage ", or any corresponding subsequent enactment".

Power of board to contribute to superannuation funds.

5. Section 52a of the principal Act is amended by striking out from the principal Act, proviso to subsection (2) the passage "eighty miles" and inserting in lieu s. 52a thereof the passage "129 kilometres".

Licensing of export meat

6. Section 78b of the principal Act is amended by striking out from Amendment of subsection (1) the passage "fifty miles" and inserting in lieu thereof the passage "80 kilometres".

Permits as to carcasses and meat from

country abattoirs.

7. Section 100 of the principal Act is amended—

Amendment of principal Act, s. 100—

(a) by striking out from paragraph (a) of subsection (2) the passage "two hundred yards" and inserting in lieu thereof the passage "183 metres";

Power to take temporary possession of land.

and

- (b) by striking out from paragraph (d) of subsection (2) the passage "five hundred yards" and inserting in lieu thereof the passage "457 metres".
- 8. Section 103 of the principal Act is amended by striking out from Amendment of subsection (3) the word "have" and inserting in lieu thereof the word "has".

principal Act, s. 103—

Compensation to be made for temporary occupation.

9. Section 106 of the principal Act is amended by striking out from Amendment of paragraph (a) of subsection (1) the word "board" and inserting in lieu thereof 106 the word "corporation".

Power to lease and sell surplus land and property.

10. Section 110 of the principal Act is repealed.

Repeal of s. 110 of the principal
