An Act to amend the Adelaide Festival Centre Trust Act 1971, the Construction Industry Long Service Leave Act 1987, the Co-operatives Act 1983, the Correctional Services Act 1982, the Dentists Act 1984, the Education Act 1972, the Equal Opportunity Act 1984, the Government Management and Employment Act 1985, the Institute of Medical and Veterinary Science Act 1982, the Medical Practitioners Act 1983, the Nurses Act 1984, the Optometrists Act 1920, the Parliament (Joint Services) Act 1985, the Police Act 1952, the Police (Complaints and Disciplinary Proceedings) Act 1985, the South Australian Health Commission Act 1976, the Starr-Bowkett Societies Act 1975, the Supreme Court Act 1935, the Technical and Further Education Act 1975 and the Veterinary Surgeons Act 1985.

The Parliament of South Australia enacts as follows:

# PART 1 PRELIMINARY

### Short title

1. This Act may be cited as the Statutes Amendment (Abolition of Compulsory Retirement) Act 1993.

### Commencement

2. This Act will come into operation on 1 January 1994.

### Interpretation

3. A reference in this Act to the principal Act is a reference to the Act referred to in the heading to the Part in which the reference occurs.

# AMENDMENT OF ADELAIDE FESTIVAL CENTRE TRUST ACT 1971

### Amendment of s. 6—Composition of the Trust

4. Section 6 of the principal Act is amended by striking out from subsection (4) "and  $n_0$  instrument of appointment shall provide for a term of appointment of a trustee that will continue after he has attained his seventieth birthday".

# Amendment of s. 17-Cessation of employment

(4a) Notwithstanding any Act or law to the contrary, a provision in an award or industrial agreement made or approved under the *Industrial Relations Act* (S.A.) 1972 that—

(a) imposes, or requires or authorises an employer to impose, a compulsory retiring age in respect of employment of any kind;

(b) requires or authorises an employer to terminate the employment of any person on the basis of the person's age,

is void and of no effect.

### Substitution of s. 7

24. Section 7 of the principal Act is repealed and the following section is substituted:

### Term of office

7. (1) The Authority will be appointed for a term of office of seven years.

(2) Subject to this Act, a person appointed to be the Authority is, on the expiration of his or her term of office, eligible for reappointment for a term of not less than three years and not more than seven years.
