An Act to amend the Agent-General Act, 1901-1953, as amended ; the Audit Act, 1921-1966, as amended ; the Industrial Code, 1967-1969 ; the Licensing Act, 1967-1969, the Police Regulation Act, 1952-1966, as amended ; the Public Service Act, 1967-1968, and the Public Service Arbitration Act, 1968, and for other purposes.

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows :

PART II

AMENDMENT OF AGENT-GENERAL ACT, 1901-1953,  
AS AMENDED

2. (1) The Agent-General Act, 1901-1953, as amended by any Acts passed before the passing of this Act, and by this Act, may be cited as the "Agent-General Act, 1901-1969". Short titles.

(2) The Agent-General Act, 1901-1953, as amended by any Acts passed before the passing of this Act, is in this Part referred to as "the principal Act".

3. Section 5 of the principal Act is amended by inserting in paragraph (b) of subsection (1) after the word "year" the passage "until the first day of December, 1969, and on and after that day at the rate of three thousand two hundred and forty pounds sterling a year". Amendment of principal Act, s. 5—  
Salary and allowances of Agent-General.

PART III

AMENDMENT OF AUDIT ACT, 1921-1966, AS  
AMENDED.

4. (1) The Audit Act, 1921-1966, as amended by any Acts passed before the passing of this Act, and by this Act, may be cited as the "Audit Act, 1921-1969". Short titles.

(2) The Audit Act, 1921-1966, as amended by any Acts passed before the passing of this Act, is in this Part referred to as "the principal Act".

5. Section 6 of the principal Act is amended—

(a) by inserting in subsection (1) after the passage "thirteen thousand dollars" the passage "until the first day of December, 1969, and on and after that day at the rate of sixteen thousand five hundred dollars a year";

and

- (b) by inserting in subsection (2) after the word "salary" the passage " , and any arrears of salary whenever accruing,".

##### AMENDMENT OF INDUSTRIAL CODE, 1967-1969

**6.** (1) The Industrial Code, 1967-1969, as amended by this Act, may be cited as the "Industrial Code, 1967-1969".

(2) The Industrial Code, 1967-1969, is in this Part referred to as "the principal Act".

**7.** Section 11 of the principal Act is amended—

(a) by striking out the word "The" being the first word in subsection (1) and inserting in lieu thereof the passage "Until the first day of December, 1969, the";

(b) by inserting after the last word in subsection (1) the passage "and on and after that day the President shall receive a salary of sixteen thousand five hundred dollars per annum and the Deputy President shall receive a salary of fourteen thousand dollars per annum";

and

(c) by inserting after the word "salaries" in subsection (2) the passage " , and any arrears of salary whenever accruing,".

##### AMENDMENT OF LICENSING ACT, 1967-1969

Short titles.

**8.** (1) The Licensing Act, 1967-1969, as amended by this Act, may be cited as the "Licensing Act, 1967-1969".

(2) The Licensing Act, 1967-1969, is in this Part referred to as "the principal Act".

**9.** Section 5 of the principal Act is amended—

(a) by striking out the word "The" being the first word in subsection (7) and inserting in lieu thereof the passage "Until the first day of December, 1969, the";

(b) by inserting in subsection (7) after the passage "eleven thousand four hundred dollars per year" the passage "and, on and after that day at the rate of fourteen thousand dollars per year";

and

(c) by inserting in subsection (9) after the word "chairman" the passage " , and any arrears of such salary whenever accruing,".

AMENDMENT OF POLICE REGULATION ACT, 1952-1966,  
AS AMENDED

10. (1) The Police Regulation Act, 1952-1966, as amended by any Acts passed before the passing of this Act, and by this Act, may be cited as the "Police Regulation Act, 1952-1969". Short titles.

(2) The Police Regulation Act, 1952-1966, as amended by any Acts passed before the passing of this Act, is in this Part referred to as "the principal Act".

11. Section 8 of the principal Act is amended—

(a) by striking out the word "The" being the first word in subsection (1) and inserting in lieu thereof the passage "Until the first day of December, 1969, the";

(b) by inserting after the last word in subsection (1) the passage "and on and after that day at the rate of fifteen thousand two hundred dollars a year";

and

(c) by inserting in subsection (3) after the word "Commissioner" the passage " , and any arrears of such salary whenever accruing,".

PART VII

AMENDMENT OF PUBLIC SERVICE ACT, 1967-1968

12. (1) The Public Service Act, 1967-1968, as amended by this Act, may be cited as the "Public Service Act, 1967-1969". Short titles.

(2) The Public Service Act, 1967-1968, is in this Part referred to as "the principal Act".

**13.** Section 15 of the principal Act is amended—

- (a) by striking out the word “The” being the first word in subsection (1) and inserting in lieu thereof the passage “Until the first day of December, 1969, the”;
- (b) by inserting after the last word in subsection (1) the passage “and on and after that day the salary of the Commissioner nominated Chairman of the Board shall be at the rate of sixteen thousand five hundred dollars a year and the salary of each of the other Commissioners shall be at the rate of fourteen thousand dollars a year”;

and

- (c) by inserting in subsection (2) after the word “section” the passage “, and any arrears of any such salary whenever accruing,”.

PART VIII

AMENDMENT OF PUBLIC SERVICE ARBITRATION  
ACT, 1968

Short titles.

**14.** (1) The Public Service Arbitration Act, 1968, as amended by this Act, may be cited as the “Public Service Arbitration Act, 1968-1969”.

(2) The Public Service Arbitration Act, 1968, is in this Part referred to as “the principal Act”.

**15.** Section 8 of the principal Act is amended—

- (a) by striking out the word “The” being the first word in subsection (1) and inserting in lieu thereof the passage “Until the first day of December, 1969, the”;
- (b) by inserting in subsection (1) after the passage “eleven thousand four hundred dollars per annum” the passage “and, on and after that day, at the rate of fourteen thousand dollars per annum,”;

and

- (c) by inserting in subsection (3) after the word “Arbitrator” the passage “, and any arrears of such salary whenever accruing,”.
