By His Excellency GEORGE GREE Esquire Governor and Commander-in-Chief of Her Majesty's Province of South Australia and its Dependencies and Vice-Admiral of the same by and with the advice and consent of the Regulate Sales by Auction and Legislative Council.

AN ORDINANCE further to Regulate Sales by Auction

WHEREAS an Act or Ordinance of the Governor of South Australia with the advice and consent of the Legislative Council was passed in the Third Year of Her Majesty's Reign intituled "An 3rd Victoria No. 14. Act to Regulate the Licensing of Auctioneers" and it is expedient to amend and extend the provisions of the same:

BE IT THEREFORE ENACTED BY HIS EXCELLENCY the Governor of South Australia with the advice and consent of the Legislative Council thereof That from and after the first day of December next Repealof former Act the before recited Act or Ordinance shall be and the same is hereby repealed and no license taken out according to the provisions thereof shall be of any force or effect: Provided always that every auction- Proviso as to holders eer so licensed who shall have paid to the Collector of Internal of existing Licenson Revenue or other proper officer the license money thereby imposed of Fifty Pounds Sterling shall and may receive a proportional remission of such license-money at the rate of four pounds sterling for every entire month then remaining unexpired of the period during

which any such license would have been in operation if this Ordinance had not been passed which remission the Colonial Treasurer is hereby authorised and required to pay accordingly on delivery of such license to be cancelled.

II. And be it further enacted that no person who shall exercise licensed according the trade or business of an Auctioneer or Seller by Commission at any sale of any estate goods or effects whatsoever by outcry knocking down of hammer by candle lot parcel or any other mode of sale at auction or whereby the highest bidder becomes the purchaser or who shall act in that capacity shall deal in sell or put up to sale any estate goods or effects whatsoever by public sale or by way of auction as aforesaid without previously having taken out a Town or Country License in manner hereinafter mentioned in which license shall be set forth the true name and real place of abode of the person taking out the same he immediately upon taking out such license paying down for the same the sum of Twenty-five Pounds Sterling.

III. And in order that the character of every person applying for, a license should be carefully ascertained be it enacted that every person who shall be desirous of obtaining an Auctioneer's License (other than such as may be licensed according to the provisions of the recited Act or Ordinance) shall apply for the same to the Bench of Magistrates nearest to his usual place of residence at any of their stated Quarterly Meetings and shall lodge such application with the Clerk to the said Bench of Magistrates at least one week before the day of their respective meetings and such Bench of Magistrates three or more being present if they be satisfied that such applicant is a person of unexceptionable character shall and they are hereby authorised and required to deliver to such applicant a certificate under their hands to that effect and upon presenting such certificate (and in the case of Auctioneers holding licenses in force at the passing hereof on presenting such license) to the Collector of Internal Revenue or other proper officer in that behalf appointed by the Governor such Collector or proper officer shall issue and deliver to the person so applying such a license as is required by this Ordinance: Provided always that conses to give Bond no Auctioneer's License shall be granted until the person applying for the same shall have lodged in the hands of the Collector of Internal Revenue or other officer aforesaid a bond to Her Majesty her heirs and successors with two sufficient sureties binding himself in the sum of Five Hundred Pounds and his surcties in the sum of One Hundred Pounds each that he will deliver every account of the Sales by him made and also make payment of every sum arising or becoming due for the Auction duty

IV. And be it further enacted that when any person applying for a Country Licenses license in manner aforesaid shall not usually residenor intend to exercise thebusiness of an Auctioneer within the City of Adelaide the proper officer shall on payment of the sum of Ten Pounds issue and deliver to such person a License to act as Auctioneer in the country districts: Provided that no such Country License shall authorise the party licensed to act as an Auctioneer within the City of Adelaide or in any place within ten miles thereof.

V. And be it further enacted that where any two persons and Partnership Licenses not more usually residing within one and the same district and having bona fide and in fact one and the same ordinary place of business only and carrying on business or purposing to carry on business together in partnership as Auctioneers shall apply in manner aforesaid to be licensed as such partners the proper officer shall on compliance with the provisions hereof issue a License to such two persons as partners accordingly on payment of the annual sum of Ten Pounds Sterling in addition to the license money payable by any single Auctioneer as aforesaid: Provided always that in every such case the bond taken in manner aforesaid shall be expressed to be applicable to both partners so to be licensed.

VI. And be it further enacted that when any such Auctioneer Auctioneer's Clerks. shall apply for a License to authorise his known clerk to act in his stead at Sales by Auction which he may be prevented by necessary causes from conducting in person the proper officer shall issue such a License accordingly on payment of the annual sum of ten pounds sterling in addition the License-money payable by such Auctioneer as aforesaid: Provided always that in every such case the bond taken in manner aforesaid shall be expressed to be applicable to the known clerk for the time being of such Auctioneer and that such Auctioneer shall from time to time as occasion may require enter the name of such clerk at the office of the Collector of Internal Revenue who is hereby authorised and required to register the same on the back of the bond on payment for every such registration of a fee of ten shillings.

VII. And be it further enacted that every person who shall take out any such License as aforesaid is hereby required to take out a iresh License ten days at least before the expiration of twelve calendar months after the taking out the first License, before he act as an Auctioneer as aforesaid and in the same manner to renew every such License from year to year paying the same regulated dues for

each and every new and renewed License and if any person shall act as an Auctioneer contrary to the provisions hereof without taking out such License or renewing the same yearly in manner aforesaid such person shall forfeit and pay for every such offence the sum of one hundred pounds.

VIII. And be it further enacted that there shall be raised levied pound to be levied collected and paid in such manner as hereafter is mentioned to and for the use of Her Majesty her heirs and successors for and upon all manner of Sales by Auction within the said Province the rate and duty hereinafter expressed that is to say the sum of four pence for every twenty shillings and so on in proportion for every greater or less sum of the purchase money arising from the Sale by Auction of any estate goods or effects whatsoever the said rate and duty to be paid by every such Auctioneer or Seller by Commission out of the monies arising at each and every such Sale or Auction as aforesaid.

IX. Provided always and be it enacted and declared that the progoods sold in the visions hereof shall extend and apply to all estates goods or effects Auction Room sub- which may subsequently to any auction be sold by commission in the auction-room and to all property sold with reference to the prices at any previous auction or for which the benefits of an auction have been obtained whether sold by any such auctioneer or any person employed on his behalf.

X. And be it further enacted that the said rate and duty by this the Auctioneer from Ordinance imposed shall be and is hereby declared to be a charge bidding at every sale. upon every Auctioneer or Seller by Commission immediately from and after the knocking down of the hammer or other closing the bidding at every Sale by way of Auction and that the rates and duties so charged shall be paid by every such Auctioneer or Seller by Commission in the manner and at the times hereinafter mentioned.

XI. And be it further enacted that each and every person so acting as Auctioneer as aforesaid shall and he is hereby required within fourteen days after the expiration of every calendar month to deliver or cause to be delivered to the Collector of Internal Revenue for the time being or at his office or to such other person as shall from time to time be authorised by the Governor to receive the same an exact and particular account in writing of the total amount of money that shall have been bidden at each and every Sale together with a return of the daily amount of the Sales which shall have been had and holden by such Auctioneer during the said month together with the time or times when and the place or places where such Salo

void the duty paid of estates or goods may be rendered null and void by reason that thereon is to be returned the person or persons for whose benefit the same shall be rely to the person or persons for whose benefit the same shall be sold had no title to or no right to dispose of the same be it therefore enacted that if any Sale by Auction of any estate goods or effects shall be rendered void by reason that the person for whose benefit the same was sold had no title to the same or no right to dispose thereof then and in every such case it shall and may be lawful for the Auctioneer who paid the duty for estates goods or effects so sold or for the person or persons for whose benefit the same was so sold to apply to the said Collector of Internal Revenue or to the person who shall be appointed as aforesaid for a return of the duty so paid and the said Collector or the person so appointed as aforesaid shall and is hereby required to hear and investigate all such applications and examine the witnesses upon oath who shall be produced on the part of the party or parties making such application which oath the said Collector of Internal Revenue or other person appointed as aforesaid is hereby empowered to administer and thereupon to report the case to the said Governor or Acting Governor who upon being satisfied as to the justness of the application may order the amount of duty which shall have been so paid as aforesaid to be refunded and paid to such Auctioneer or such other person on whose behalf the same shall have been originally paid to such Collector of Internal Revenue or other person appointed as aforesaid anything in this Ordinance to the contrary notwithstanding.

Sale without fraud or collusion then and in such case the said Collector or other person appointed to receive the duties is and are respectively hereby authorised and empowered to make an allowance to such owner of the duties arising by this Ordinance upon such bidding provided notice be given to the Auctioneer before such bidding both by the owner and the person intended to be the bidder of the latter being appointed by the former and having agreed accordingly to bid at the Sale for the use and behoof of the seller and provided such notice be verified if required by the oath of the Auctioneer as also by evidence to be given of the fairness and reality of the transaction according to the best of his knowledge and belief and in case any dispute shall arise whether such purchase by the owner was not made by collusion or in order to lessen the full sum appointed by this Ordinance to be paid or concerning the fairness of such transaction then and in such cases the proof thereof shall lie upon the person acting as Auctioneer

and on failure therein or in case of any unfair practice then no such allowance shall be made as aforesaid.

XIV. And be it further enacted that all fines penalties and Recovery and appliforfeitures imposed by this Ordinance if exceeding the sum of fifty pounds shall be recovered by Action of Debt Bill or Information in the Supreme Court and if not exceeding the said sum shall be recovered summarily before any two or more Justices of the Peace according to the Law of the Province regulating summary proceedings before Justices and the money arising by all such fines penalties and forfeitures respectively when recovered shall be applied two thirds thereof to our Sovereign Lady the Queen her Heirs and Successors for the public uses of the Province and support of the Government thereof and the other third to the use of the person informing and suing for the same.
