An Act to revise the Statute law and for other purposes.

[Assented to, November 15th, 1934.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

- 1. This Act may be cited as the "Statute Law Revision short title. Act, 1934."
- 2. (I) The Acts named in Part I. of the First Schedule Repeal of certain obsolete and spent are hereby repealed.

- (2) The Acts, the numbers and years of which are mentioned in Part II. of the First Schedule, being Acts for the appropriation of revenue, are hereby repealed.
- (3) The Acts, the numbers and years of which are mentioned in Part III. of the First Schedule, being Acts for the granting of supply, are hereby repealed.
- (4) If the Governor is of opinion that any Act repealed by this section should be revived, the Governor may by proclamation declare that Act to be revived, and thereupon that Act shall be deemed to be revived and to have continued in force as from the date of the repeal thereof by this section, but no person shall be subjected to any criminal proceedings in respect of anything done subsequent to any such repeal and prior to any such revival.

Saving provision.

- 3. (1) Any repeal under section 2 shall not affect—
 - (a) the validity or invalidity of anything done or suffered before the repeal:
 - (b) the validity or invalidity of anything declared to be valid or invalid by any Act so repealed:
 - (c) any right, interest, title, power, or privilege existing or accruing under any Act so repealed:
 - (d) the proof of any past act or thing:
 - (e) the recognition in South Australia under any Act so repealed of any status, right, title, or other matter or thing elsewhere acquired in the same circumstances and to the same extent as such recognition would have been granted or given prior to the passing of this Act.
- (2) This section shall not limit the application of any provision of the Acts Interpretation Act, 1915, to any such repeal

Amendment of certain Acts.

4. The Acts mentioned in the Second Schedule are amended in the manner shown in the said Schedule.

An Act to amend the Lights on Vehicles Acts, 1919 to 1931.

[Assented to, November 22nd, 1934.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

- 1. This Act may be cited as the "Lights on Vehicles Act short title. Amendment Act, 1934".
- 2. This Act shall come into operation on a day to be commencement fixed by proclamation, which shall not be earlier than the first day of March, 1935.
- 3. Section 6 of the Lights on Vehicles Act, 1919, is Amendment of s. 6 of Lights on Vehicles, so as to read as follows:—

 Amendment of s. 6 of Lights on Vehicles Act, 1919—

 Act, 1919 amended, so as to read as follows:

- 6. (1) No person shall ride any bicycle or tricycle upon Lights on any road or street at any time between half an hour after tricycles. sunset and half an hour before sunrise unless it has attached thereto either one or two lighted lamps complying with this section.
- (2) Where one lamp is carried it shall be affixed on the off side of the bicycle or tricycle in such a position and manner as to show a bright white light clearly visible to any person appproaching the bicycle or tricycle from the front and a red light clearly visible to any person approaching the bicycle or tricycle from the rear.

Lights on Vehicles Act Amendment Act.—1934.

- (3) Where two lamps are carried—
 - (a) one shall be affixed on the front of the bicycle or tricycle in such a position and manner that a bright white light from the lamp is clearly visible to any person approaching the bicycle or tricycle from the front; and
 - (b) one shall be affixed on the rear of the bicycle or tricycle in such a position and manner that a red light from the lamp is clearly visible to any person approaching the bicycle or tricycle from the rear.
- (4) In this section the term "visible" means "visible at a distance of at least fifty yards from the bicycle or tricycle on which the lamp or lamps is or are carried".
- (5) This section shall not apply to any part of the State not comprised within a municipality or a district council district or the Garden Suburb.
