An Act to amend the Art Gallery Act, 1939, the Bail Act, 1985, the Bills of Sale Act, 1886, the Equal Opportunity Act, 1984, the Legal Practitioners Act, 1981, the South Australian Health Commission Act, 1976, and the Summary Offences Act, 1953.

[Assented to 26 April 1990]

The Parliament of South Australia enacts as follows:

Short title

1. This Act may be cited as the Statute Law Revision Act, 1990.

Commencement

2. This Act will come into operation on a day to be fixed by proclamation.

Amendment of Acts specified in the schedules

3. (1) The Acts specified in the schedules to this Act are amended in the manner indicated in those schedules.

(2) If an Act sought to be amended by a schedule to this Act is, before the commencement of that schedule, amended in a manner that renders an amendment contained in the schedule ineffective, that amendment will be taken to have been struck out.
