#### A.D. 1965

### No. 39 of 1965

An Act to revise the Statute Law and for other purposes.

[Assented to 9th December, 1965.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

Short title.

- 1. This Act may be cited as the "Statute Law Revision Act, 1965".
- Repeal of Sand Drift Act and Travelling Stock Waybills Act.
- 2. The Acts mentioned in the first column of the first schedule to this Act are repealed as respectively specified in the second column of that schedule.

Amendment of certain Acts.

3. The Acts mentioned in the first column of the second schedule to this Act are amended respectively in the manner set out in the second column of that schedule.

Amendment of Mines and Works Inspection Act Amendment Act, 1964. 4. The amendments of the Mines and Works Inspection Act Amendment Act, 1964, effected by this Act shall be deemed to have come into operation upon the commencement of that Act.
