## No. 31 of 1968

An Act to amend the Tatiara Drainage Trust Act, 1949.

[Assented to 12th December, 1968.]

BE IT ENACTED by the Governor of the State of South Australia, with the advice and consent of the Parliament thereof, as follows:

Short titles.

- 1. (1) This Act may be cited as the "Tatiara Drainage Trust Act Amendment Act, 1968".
- (2) The Tatiara Drainage Trust Act, 1949, as amended by this Act, may be cited as the "Tatiara Drainage Trust Act, 1949-1968".
- (3) The Tatiara Drainage Trust Act, 1949, is hereinafter referred to as "the principal Act".

Amendment of principal Act, s. 3—
Arrangement of Act.

2. Section 3 of the principal Act is amended by striking out the passage "Tatiara Creek" and inserting in lieu thereof the passage "the district".

Amendment of heading of Part V of principal Act. 3. The heading of Part V of the principal Act is amended by striking out the passage "TATIARA CREEK" and inserting in lieu thereof the passage "THE DISTRICT".

Amendment of principal Act, s. 44—
Licences for drainage work.

- 4. Section 44 of the principal Act is amended—
  - (a) by striking out the passage "the flow of water in the Tatiara Creek or of water which may overflow from that creek unless he has obtained from the

trust a licence to construct that work" in subsection (1) and inserting in lieu thereof the following:—

> (a) the flow of water in the Tatiara Creek, or of water that may overflow from that creek;

(b) the drainage of water over, upon or through land in the district,

unless he has obtained from the trust a licence to construct that work.;

- (b) by striking out the passage "the flow of water in the Tatiara Creek or of water which overflows from that creek unless he has obtained from the trust a licence to do so" in subsection (2) and inserting in lieu thereof the following:-
  - (a) the flow of water in the Tatiara Creek, or of water that overflows from that creek:

(b) the drainage of water over, upon or through land in the district,

unless he has obtained from the trust a licence to do so.

5. Section 50 of the principal Act is amended by striking amendment of out subsection (2) and inserting in lieu thereof the following s. 50 subsection :-

Removal of

- (2) Where any drainage work that diverts, prevents, restricts, controls, regulates or otherwise affects-
  - (a) the flow of water in the Tatiara Creek or of water that overflows from that creek;

(b) the drainage of water over, upon or through land in the district,

has been constructed before the commencement of the Tatiara Drainage Trust Act Amendment Act, 1968, and the trust is of the opinion that the drainage work has caused or will cause injury to any land (including any road or street) it may by notice in writing order the occupier of the land on which it is constructed to take such action as is specified in the notice to demolish the drainage work or to render it ineffective.
