An Act to further amend "The Licensed Victuallers Act, 1880."

[Assented to, December 21st, 1901.]

BE it Enacted by the Governor, with the advice and consent of the Parliament of South Australia, as follows:

1. This Act may be cited as "The Licensed Victuallers Further Amendment Act, 1901," and shall be read and construed with "The Licensed Victuallers Act, 1880," and with all other Acts incorporated therewith. Title and incorporation.

2. In addition to licences provided to be granted there shall be one to be denominated a brewer's colonial ale licence, which shall be granted only to brewers of ale, stout, and other fermented liquors, and shall be in the form of the Schedule X to this Act. Brewer's colonial ale licence.

3. The application for the granting of such licence shall be in the form of the Schedule Y to this Act. Application for licence.

4. Every such licence shall authorise the brewer therein licensed to sell and dispose of liquor on the premises therein specified, in quantities of not less at one time than two gallons of one kind of spirits or one dozen reputed quart bottles or two dozen reputed pint bottles of wine or other fermented liquor to be taken away at one time by one person, and not to be drunk on the premises in which such liquor is sold. Penalty of not less than Ten Pounds or more than Fifty Pounds. Powers under licence and penalty.

5. No person while holding a brewer's colonial ale licence shall be capable of holding a storekeeper's licence or a wine licence. Any grant of either of such last-mentioned licences to a person holding a brewer's colonial ale licence shall be void and of none effect.

Provisions relating to
storekeepers' licences
to apply to brewer's
colonial ale licence.

6. All the provisions of the Acts read and incorporated herewith referring to or dealing with storekeepers' licences shall, except where inconsistent herewith or inapplicable hereto, apply to a brewer's colonial ale licence in the same manner as if a provision had been made in such sections for such licences, in addition to storekeepers' licences.

“The Licensed Victuallers Further Amendment Act, 1901.”

Form of a Brewer's Colonial Ale Licence.

I, A. B., Clerk to the Licensing Bench of Justices for the District of _____ in the State of South Australia, do hereby certify that on the _____ day of _____, 19____, a brewer's colonial ale licence was granted by the said Licensing Bench then assembled at their meeting, held at _____ to C. D., of _____, and that the said C. D. is hereby licensed to sell and dispose of liquor in quantities of not less than two gallons in manner prescribed in “The Licensed Victuallers Further Amendment Act, 1901,” on the premises situated at [*describing them*], but such liquor shall not be drunk in or about the house or on the premises above described; and no liquor shall be sold or disposed of earlier than six o'clock in the morning or later than eleven o'clock at night. This licence shall commence on the day of the issue hereof by the Treasurer and continue in force until the twenty-fifth day of March in the year now next ensuing, inclusive, provided it be not forfeited in the meantime.
