## GEORGII V REGIS.

A.D. 1916.

## No. 1260.

An Act to authorise the construction of certain Works for the Storage and Distribution of Water, and for other purposes.

[Assented to, November 16th, 1916.]

BE it Enacted by the Governor of the State of South Australia, with the advice and correct for with the advice and consent of the Parliament thereof, as follows:

- 1. This Act may be cited as the "Tod River Waterworks Act, short title. 1916."
- 2. This Act is incorporated with the Waterworks Act, 1882, Incorporation with and all Acts incorporated with that Act except sections 110, 114, 115, 116, 117, and 118 of the Lands Clauses Consolidation Act.

3. (1) The Commissioner of Waterworks may, out of moneys Commissioner of voted by Parliament for the purpose —

Waterworks may construct Tod River Water Scheme.

(a) construct and maintain the waterworks known as the Tod River Waterworks and all other works which from time to time are found to be necessary or convenient in connection therewith, within the water district to be called the "Tod River Water District," shown and margined green on the plan deposited on the thirty-first day of October, nineteen hundred and sixteen, in the office of the Surveyor-General, marked "Tod River Water Scheme, Tod River Water District," signed "Charles A. Bayer, Hydraulic Engineer," and dated the twenty-seventh day of October, nineteen hundred (b) construct and sixteen, and

- (b) construct and maintain such works and do such things as from time to time are found to be necessary or convenient for conveying and distributing the water stored in the said waterworks to and through the said district.
- (2) The Commissioner shall call for tenders for the construction of the works, to be sent in within such time, to such place, and to be upon and subject to such terms, conditions, and provisions as he deems advisable, and may accept or reject any tender; and he may construct the works himself if no tender for the construction thereof is accepted.
- (3) All payments in respect of any contract entered into by the Commissioner for the construction of the works shall be made in cash and not by Inscribed Stock, Treasury Bills, or any other form of Government security.

Districts which may be supplied.

- 4. The water stored in the said waterworks may be used—
  - (a) for the supply of the Tod River Water District, and
  - (b) for the further supply of any other water district.

Meaning of Tod River Water District.

- 5. The Tod River Water District is hereby constituted and declared to be a water district for the purposes of the Waterworks Act, 1882.
- 6. In this Act the term "Tod River Water District" means the Tod River Water District referred to in section 3 of this Act, with any additions which at any time may be made thereto by proclamation under the Waterworks Act, 1882, or the said Tod River Water District as the same for the time being exists in consequence of any alterations of the boundaries thereof so made.

Lands separated from main by railway reserve to be ratable.

- 7. (1) Lands and premises within the Tod River Water District shall be deemed to be abutting on the mains and pipes of reticulation laid down by the Commissioner of Waterworks under this Act notwithstanding that they are separated therefrom by a railway line  $\frac{\text{and}}{\text{or}}$  any land appurtenant thereto and any road adjoining such land.
- (2) Such lands and premises shall be ratable by the Commissioner of Waterworks under the Acts incorporated herewith in the same manner as if such lands and premises were situated in a street wherein a main pipe had been laid down by the Commissioner for the purpose of supplying water to such lands and premises.
