## VICTORIÆ REGINÆ,

*By His Excellency SIR WILLIAM THOMAS DENISON, Knight,  
Lieutenant-Governor of the Island of Van Diemen's Land  
and its Dependencies, with the Advice and Consent of the  
Legislative Council.*

*AN ACT for applying certain Sums arising from the  
Revenue receivable in the Colony of Van Diemen's  
Land to the Service thereof for the Year One thousand  
eight hundred and fifty-two and for further appro-  
priating the said Revenue.*

**W**E Her Majesty's most dutiful and loyal Subjects the Members of the Legislative Council of Van Diemen's Land in Council assembled towards making good the Supply which we have cheerfully granted to Her Majesty in this Session of the said Legislative Council have resolved to grant unto Her Majesty's Service the sums hereinafter mentioned and do therefore respectfully request that in pursuance of a certain Act of Parliament passed in the fourteenth year of the reign of Her present Majesty Queen VICTORIA intituled *An Act for the better Government of Her Majesty's Australian Colonies* whereby it was among other things enacted that the Governor of the Colony of Van Diemen's Land with the advice and consent of the Legislative Council thereof should have authority to make Laws for the peace welfare and good government of the said Colony and with the deductions and subject to the provisions therein contained by such Laws to appropriate to the Public Service within the said Colony the whole of Her Majesty's Revenue within such Colony arising from Taxes Duties Rates and Imposts levied on Her Majesty's Subjects within such Colony it may be enacted **AND BE IT THEREFORE ENACTED** by His Excellency Sir WILLIAM THOMAS DENISON Knight Lieutenant-Governor of the Island of Van Diemen's Land and its Dependencies by and with the advice and consent of the Legislative Council thereof that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service within the said Colony and

issued and applied any sum or sums of money not exceeding seventy-three thousand nine hundred and eighty-three pounds fifteen shillings and sixpence to defray the Salaries Allowances and Contingencies of the Civil and Legislative Departments of the said Colony unprovided for by the Schedule annexed to the said recited Act of Parliament marked C for the year one thousand eight hundred and fifty-two as hereinafter more particularly expressed—that is to say—any sum or sums of money not exceeding six hundred and sixty-nine pounds seventeen shillings to defray the Salaries Allowances and Contingencies of His Excellency the Lieutenant-Governor's Establishment and any sum or sums of money not exceeding two thousand nine hundred and twenty-two pounds sixteen shillings to defray the Salaries and Contingencies of the Legislative Council Establishment and any sum or sums of money not exceeding five thousand seven hundred and eighty-one pounds to defray the Salaries and Contingencies of the Customs' Department and any sum or sums of money not exceeding four thousand two hundred and ninety-five pounds and three pence to defray the Salaries and Contingencies of the Post Office Establishment and any sum or sums of money not exceeding eight hundred and fourteen pounds to defray the Salaries and Contingencies of the Department of the Accountant of Stores and any sum or sums of money not exceeding four thousand five hundred and ninety-four pounds nine shillings to defray the Salaries Allowances and Contingencies of the Department of the Port Officer and any sum or sums of money not exceeding three thousand three hundred and ninety-four pounds six shillings and ten pence to defray the Salaries Allowances and Contingencies of the Department of Public Works and any sum or sums of money not exceeding one thousand four hundred and twenty-four pounds to defray the Salaries Allowances and Contingencies of the Establishment of the Government Printer and any sum or sums of money not exceeding six hundred and seventy-eight pounds to defray the Salaries Allowances and Contingencies of the Department of the Registrar of Births Deaths and Marriages and any sum or sums of money not exceeding ninety pounds to defray the Salaries of the Inspectors of Weights and Measures and any sum or sums of money not exceeding nine hundred and twenty-three pounds to defray the Salaries and Contingencies of the Education Department and any sum or sums of money not exceeding forty-eight thousand one hundred and thirty-seven pounds six shillings and five pence to defray the Salaries Allowances and Contingencies of the Police and Gaols' Establishment and any sum or sums of money not exceeding one hundred and sixty pounds to defray the Salaries and Contingencies of the Miscellaneous Establishment and any sum or sums of money not exceeding one hundred pounds to defray the Salary of the Agent-General in London.

II. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding two thousand four hundred and thirty-four pounds to defray the charge for Revenue Services (exclusive

of Establishments) of the said Colony for the year one thousand eight hundred and fifty-two.

III. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding five thousand five hundred and forty-five pounds to defray the charge for Charitable Allowances of the said Colony for the year one thousand eight hundred and fifty-two.

IV. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding five thousand one hundred and thirty-five five pounds to defray the charge for Education (exclusive of Establishment) of the said Colony for the year one thousand eight hundred and fifty-two.

V. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding five hundred pounds to defray the charge for Government Printer (exclusive of Establishment) of the said Colony for the year one thousand eight hundred and fifty-two.

VI. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding two thousand nine hundred and seventy-three pounds ten shillings to defray the charge of Police and Gaols (exclusive of Establishment) of the said Colony for the year one thousand eight hundred and fifty-two.

VII. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding three hundred and forty-nine pounds thirteen shillings and four pence to defray the charge of Rent in the said Colony for the year one thousand eight hundred and fifty-two.

VIII. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding one thousand nine hundred and sixty pounds to defray the charge of Transport in the said Colony for the year one thousand eight hundred and fifty-two.

IX. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding two thousand and eighty-one pounds

to defray the charge of Conveyance of Mails of the said Colony for the year one thousand eight hundred and fifty-two.

X. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding nine thousand three hundred and seven pounds fourteen shillings and nine pence to defray the charge of Public Works and Buildings in the said Colony for the year one thousand eight hundred and fifty-two.

XI. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding six thousand one hundred and sixty-seven pounds nineteen shillings and five pence to defray the charge of Roads Streets *et cetera* in the said Colony for the year one thousand eight hundred and fifty-two.

XII. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding two thousand four hundred and sixty-four pounds ten shillings to defray Miscellaneous Charges of the said Colony for the year one thousand eight hundred and fifty-two.

XIII. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding one thousand and fifty pounds to defray the charge of Grants in aid of Public Institutions in the said Colony for the year one thousand eight hundred and fifty-two.

XIV. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding five hundred pounds to defray the charge of Drawbacks in the said Colony for the year one thousand eight hundred and fifty-two.

XV. AND BE IT ENACTED that out of the produce of the said Taxes Duties Rates and Imposts there shall and may be appropriated to the Public Service of the said Colony and issued and applied any sum or sums of money not exceeding five thousand nine hundred and ninety-four pounds seven shillings and two pence to defray the Supplementary Charge on the Colonial Treasury of the said Colony for the year one thousand eight hundred and fifty-one as hereinafter more particularly expressed—that is to say—any sum or sums of money not exceeding five pounds to defray the expenses of the various items under

the head of Clerk of the Councils and any sum or sums of money not exceeding ten pounds to defray the expenses under the head of Port Officer and any sum or sums of money not exceeding eighty-eight pounds two shillings and sixpence to defray the expenses of the various items under the head of Public Works and any sum or sums of money not exceeding four hundred and ninety-nine pounds seven shillings and sixpence to defray the expense under the head of Ecclesiastical and any sum or sums of money not exceeding three hundred and seventy-six pounds two shillings and eleven pence to defray the expenses under the head of Police and Gaols and any sum or sums of money not exceeding two hundred and sixty-six pounds twelve shillings and sixpence to defray the expenses under the head of Water Police and any sum or sums of money not exceeding thirty-eight pounds sixteen shillings to defray the expense under the head of Pensions and any sum or sums of money not exceeding two hundred and fifty-three pounds one shilling and four pence to defray the expenses of the various items under the head of Revenue Services and any sum or sums of money not exceeding seventeen pounds seventeen shillings to defray the expenses under the head of Administration of Justice and any sum or sums of money not exceeding nine hundred and ninety-six pounds nineteen shillings and ten pence to defray the expenses under the head of Charitable Allowances and any sum or sums of money not exceeding three hundred and sixty-nine pounds to defray the expenses under the head of Education and any sum or sums of money not exceeding four hundred and sixteen pounds sixteen shillings to defray the expenses under the head of Police and Gaols and any sum or sums of money not exceeding nineteen pounds nine shillings and four pence to defray the expense of the various items under the head of Rent and any sum or sums of money not exceeding two hundred and sixty-seven pounds three shillings and five pence to defray the expense of the various items under the head of Transport and any sum or sums of money not exceeding thirty-five pounds to defray the expense for the Conveyance of Mails and any sum or sums of money not exceeding six hundred and sixty-three pounds eight shillings and eleven pence to defray the expenses under the head of Works and Buildings and any sum or sums of money not exceeding one hundred and thirty-four pounds two shillings and sixpence to defray the expenses under the head of Roads and Streets and any sum or sums of money not exceeding one thousand four hundred and seventy-three pounds two shillings and five pence to defray the expenses under the head of Miscellaneous and any sum or sums of money not exceeding sixty-four pounds five shillings to defray the expenses under the head of Grants in aid of Public Institutions.

XVI. AND BE IT ENACTED that the Treasurer of the said Colony shall issue and pay the said several sums to such persons for the purposes hereinbefore mentioned upon such days and in such proportions as the Lieutenant-Governor for the time being by any Warrant or Order in writing to be signed by him shall from time to time order and direct and that the payments so to be made shall be charged upon and payable out of the Revenues of the said Colony.

XVII. AND BE IT ENACTED that the said Treasurer shall in his Accounts from time to time be allowed credit for any sum or sums of money paid by him in pursuance of such Warrant or Order in writing as aforesaid and that the receipt or receipts of the respective persons to whom the same shall be so paid shall be a full and valid discharge to the said Treasurer in passing his said Accounts for any such sum or sums as shall be therein mentioned and that he shall and do receive credit for the same accordingly.
