Baronet, Lieutenant-Governor of the Island of Van Diemen's
Land and its Dependencies.*

*AN ACT to amend an Act of this Island passed in the
Sixth Year of the Reign of Her present Majesty
intituled An Act for making and maintaining a Bridge
over the South Esk River at Reibey's Ford.*

WHEREAS an Act was passed in the Sixth Year of the Reign of PREAMBLE.
Her present Majesty intituled *An Act for making and maintaining a
Bridge over the South Esk River at Reibey's Ford*—AND WHEREAS
Thomas Reibey in the said Act named died within the time in the
said Act appointed for the execution by him of the Bond mentioned in
the said Act and without having executed the said Bond—AND
WHEREAS in pursuance of the proposal of the said Thomas Reibey
to erect a Bridge as in the said Act mentioned at Reibey's Ford on the
South Esk River the said Bridge hath been erected and is now com-
pleted by James Haydock Reibey and John Atkinson executors of the
said Thomas Reibey out of the moneys of the estate of the said Thomas
Reibey—AND WHEREAS the said James Haydock Reibey is dead
and the said John Atkinson is now the sole surviving executor of the
said Thomas Reibey and it is expedient under the circumstances afore-
said that the said John Atkinson as such executor should now be
placed in respect of the matters aforesaid in such and the same situation
as he would have been if the said Thomas Reibey had executed the
said Bond and erected the said Bridge in his lifetime—

BE IT THEREFORE ENACTED by His Excellency SIR JOHN
EARDLEY EARDLEY-WILMOT Baronet Lieutenant-Governor of the Island
of Van Diemen's Land and its Dependencies with the advice of the
Legislative Council that from and after the time when this Act shall

come into operation the said John Atkinson as such executor as aforesaid shall have exercise possess and enjoy all such and the same rights powers privileges and advantages whatsoever under the said recited Act in as full and ample a manner as he would or might have done if the said Thomas Reibey had executed the Bond in the said recited Act mentioned anything therein contained to the contrary notwithstanding.

II. AND BE IT FURTHER ENACTED that it shall be lawful for the Lieutenant-Governor of this Island or other Officer for the time being administering the Government thereof at any time within thirty years from the completion and opening of the said Bridge with the advice of the Executive Council to pay off the principal sum of One Thousand Pounds mentioned in the seventh section of the said recited Act or any part thereof then remaining due with the interest thereon to the person or persons then entitled to receive the same and thereupon the rights and interests of the said Thomas Reibey his executors administrators and their assigns under the said recited Act shall be vested by force of this Act and without any conveyance in such person or persons as the said Lieutenant-Governor or Officer for the time being administering the Government of this Island shall appoint.
