AN ACT to authorise certain Persons to A.D. 1891. select and acquire certain Areas of Crown [23 December, 1891.] Land.

WHEREAS by the Seventh Section of "The Immigration Act, PREAMBLE. .1867," now repealed, it was enacted that any person receiving a 31 Vict. No. 26. Certificate to select land pursuant to the provisions of that Act should make such selection within Twelve months after the date of such

And whereas certain persons obtained such Certificates as aforesaid and, by reason of delay or otherwise, failed to make any selection of land as aforesaid within the prescribed time:

And whereas certain other persons, from various causes, failed to

obtain such Certificates as aforesaid upon their arrival in *Tasmania*:

Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:

1 Notwithstanding anything to the contrary contained in any Act, Power to persons or in any Order of the Board of Immigration, the persons named in the named in Schedules shall have the right to select and acquire the areas set Schedule to opposite to their names, in the same manner and under the same conditions as if they had selected the land to which they were entitled within the time prescribed by the Seventh Section of "The Immigration Act, 1867."

2 Notwithstanding anything to the contrary in any Act contained it shall be lawful for the Governor in Council by Grant Deed to convey and alienate in fee simple or any other less estate or interest the land set forth in the Schedule (2.) to the persons therein set opposite to the said land respectively.
