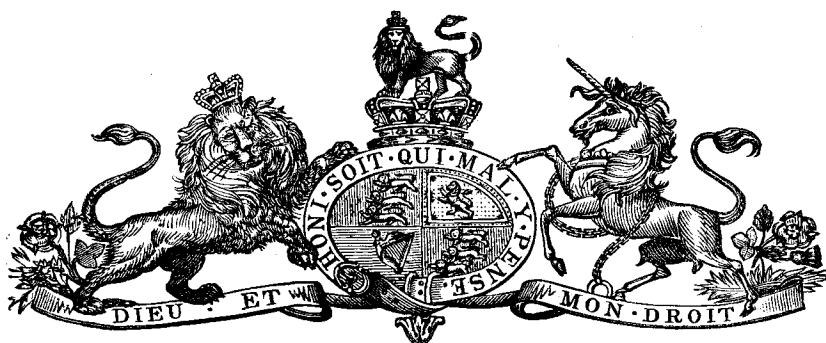

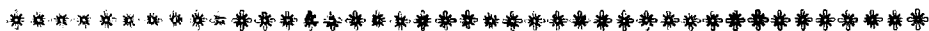

AN ACT to authorise the issue of Grants of A.D. 1894.
certain pieces of Land to certain Persons.

[3 September, 1894.]

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 The Governor is hereby authorised, in the name and on behalf of Her Majesty the Queen, to convey and alienate the land described in the Schedule (1.) hereto to *William Taylor*, and the land described in the Schedule (2.) hereto to *Sophia Mary Bignold*, respectively, in fee simple, or for any less estate or interest, under and subject to the various provisions contained in "The Crown Lands Act, 1890," and any Regulations in force at the passing of this Act, and made and published under the said Act or under any Act repealed by the said Act.

COUNTY OF BUCKINGHAM.

PARISH OF KINGBOROUGH.

67A. 1R. 27P.

Bounded on the east by twenty-seven chains and two links northerly in several bearings along Lot 631 purchased by William Roberts commencing at the south-west angle thereof, on the north east by ten chains and ninety-two links north-westerly in several bearings along land purchased by Richard Charles Rollins, on the south east by two chains and thirty-two links north-easterly also along that land, again on the north east by sixteen chains and sixty-six links north-westerly along land purchased by Alfred James Page, on the south west by twenty-seven chains and twenty-five links south-easterly along land purchased by Daniel Crane (crossing a reserved road one chain wide), on the south east by sixteen chains and twenty links north-easterly in two bearings along Crown land and along Lot 2231 purchased by John Williams (crossing another reserved road one chain wide), on the west by four chains and three links southerly along the last-mentioned land, and thence on the south west by nine chains and thirty-seven links south-easterly along Lot 228 purchased by George Drew (re-crossing the first-mentioned reserved road) to the point of commencement.

COUNTY OF BUCKINGHAM.

PARISH OF BAGOT.

40A. 2R. 11P.

Bounded on the north by twenty-six chains and fifty-two links westerly along Lot 9350 purchased by Philip Ernest Grove and along Crown land commencing at the south-east angle of Lot 9350, on the west by fifteen chains and thirty-three links southerly along Lot 12,287 purchased by Sophia Mary Bignold, on the south by twenty-six chains and forty-six links easterly also along that land, along a reserved road, and along Lot 9773 purchased by Richard James Lucas, and thence on the east by fifteen chains and thirty links northerly along Lot 10,745 purchased by Hugh Smith Kerr, along a reserved road, and again along Lot 10,745 to the point of commencement.
