AN ACT to authorise the raising of a Sum not A.D. 1874.  
exceeding £63,300 by Debentures.  
[18 September, 1874.]

**W**HEREAS it is expedient to raise a Sum not exceeding £63,300 PREAMBLE.  
by Debentures, secured upon "The Consolidated Revenue Fund," for  
the purposes of this Act :

Be it therefore enacted by His Excellency the Governor of *Tasmania*,  
by and with the advice and consent of the Legislative Council and  
House of Assembly, in Parliament assembled, as follows :—

**1** It shall be lawful for the Governor to cause to be raised, by the issue Governor may  
and sale of Debentures, secured on "The Consolidated Revenue Fund," raise £63,300 by  
in like manner as is prescribed in the Act 20 *Victoria*, No. 9, such sum or Debentures.  
sums of money, not exceeding in the whole £63,300, as may be  
required for the purposes set forth in the Schedule.

**2** All such Debentures shall bear Interest at the rate of Five Pounds Rate of Interest  
per centum per annum, and shall be redeemable as follows :— and date of re-  
demption.  
As to the sum of £13,300 in the year 1880 :  
As to the sum of £50,000 in the year 1890.

**3** All provisions contained in the said Act of the 20 *Victoria*, No. 9, Application of  
shall apply and extend to the Debentures to be issued in pursuance of 20 Vict. No. 9.  
this Act.
