AN ACT to authorise the raising of the A.D. 1892. Sum of Six hundred thousand Pounds by the Issue of *Tasmanian* Stock.

[21 December, 1892.]

WHEREAS it is expedient to raise the sum of Six hundred PREAMBLE. thousand Pounds by the issue of *Tasmanian* Stock secured on "The Consolidated Revenue Fund:"

Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 The Governor may, from time to time, issue Tasmanian Stock Stock may be charged and secured on "The Consolidated Revenue Fund" to an issued under this amount not exceeding Six hundred thousand Pounds for the purposes Act. mentioned in the Schedule.

Such Stock shall be issued in the manner provided by "The 52 Vict. No. 55. Inscribed Stock Act, 1889," and shall be subject to all the provisions of that Act.

2 All Stock issued under the provisions of this Act shall be Redemption of redeemable not later than the year One thousand nine hundred and Stock. forty, and shall bear interest at a rate not exceeding Three Pounds Rate of interest. and Ten Shillings per centum per annum.

Payment of interest on such Stock.

3 The interest on all Stock issued under the authority of this Act shall be payable half-yearly, on the First day of *January* and the First day of *July* in every year; and all such interest shall be charged upon and be issued out of "The Consolidated Revenue Fund," and the principal moneys secured by such Stock shall be a charge upon such Fund until repaid.
