### AN ACT to declare the Town of Launceston A.D. 1888. [16 October, 1888.] a City.

W HEREAS it is expedient to declare the Town of Launceston to be a City:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :-

1 The Town of Launceston is hereby declared to be a City; and, on Town of Launcesand after the day on which this Act comes into operation, shall be ton to be a City. called, in all Acts of Parliament, deeds, and documents, the City of Launceston.

2 The Body Corporate and Politic constituted by The Launceston Name of Body Corporation Act, and known by the name of the Mayor, Aldermen, and Corporate. Burgesses of the Town of Launceston, shall, on and after the day on which this Act comes into operation, be known as the Mayor, Aldermen, and Citizens of the City of Launceston.

3 Every Act of Parliament and deed and document in which the Town to be read Town of Launceston is mentioned or referred to shall, on and after the as City. day on which this Act comes into operation, be read and construed as if the City of Launceston was therein mentioned or referred to in every place in which such Town is mentioned or referred to.

4 Every Act of Parliament and deed and document in which the Mayor of the Town of Launceston is mentioned or referred to shall, on and after the day on which this Act comes into operation, be read and construed as if the Mayor of the City of Launceston was therein mentioned or referred to in every place in which such Mayor is mentioned or referred to.

5 Every Act of Parliament and deed and document in which the Mayor and Aldermen or Aldermen or the Municipal Council of the Town of Launceston are mentioned or referred to shall, on and after the day on which this Act comes into operation, be read and construed as if the Mayor and Aldermen or Aldermen or the Municipal Council of the City of Launceston were therein mentioned or referred to in every place in which such Mayor and Aldermen or Aldermen or Municipal Council are mentioned or referred to.

Where Burgesses 6 Every Act of Parliament and deed and document in which the Burgesses of the Town of Launceston are mentioned or referred to shall, on and after the day on which this Act comes into operation, be read and construed as if the Citizens of the City of Launceston were therein mentioned or referred to in every place in which such Burgesses are mentioned or referred to.
