

AN ACT to enable the Board and Electors of A.D. 1894. the Town of *Devonport* and the Trustees of the Road District of Tarleton to borrow certain Moneys. [1 August, 1894.]

W HEREAS by the Act of the Parliament of Tasmania, 55 Vic- PREAMBLE. toria, No. 56, the Minister of Lands and Works is authorised to expend the sum of Five hundred Pounds to construct a Road from "West Devonport along Esplanade to Main Road Latrobe to Don":

And whereas the Board and Electors of the Town of *Devonport*, hereinafter referred to as "the said Board and Electors," and the Trustees of the Road District of *Tarleton*, hereinafter referred to as "the said Trustees," have each agreed to contribute towards the cost of making the said Road :

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :----

1 The said Board and Electors may borrow in any of the modes Board may authorised by "The Local Bodies Loans Act" a sum or sums not borrow £1000 and lend portion exceeding One thousand Pounds for the purpose of constructing the and lend portion said Road, and may lend a sum or sume not exceeding Five hundred thereof. said Road, and may lend a sum or sums not exceeding Five hundred Pounds (part thereof) to the said Trustees for the purposes aforesaid, taking such security for the repayment thereof, with interest, as the said Board and Electors shall think fit.

Devonport Corporation Amendment.

2 The said Trustees may borrow in any of the modes authorised by "The Local Bodies Loans Act" a sum or sums not exceeding Five

Trustees may borrow £500.

Minister may pay sum of £500 to Board or Trustees.

3 As soon as the said Board and Electors have borrowed and set apart the sum of Seven hundred Pounds for the purpose of constructing the said Road, it shall be lawful for the Minister of Lands and Works to pay to the said Board and Electors the said sum of Five hundred Pounds authorised as aforesaid to be expended by him.

4 All the provisions of "The Local Bodies Loans Act," except Sections Four, Five, and Fourteen to Twenty-five, both included, shall apply to each of the Loans hereby authorised, and, except as aforesaid, "The Local Bodies Loans Act" and "The Local Bodies Loans Amendment Act" are incorporated with this Act.
