

## ALBERT HENRY JACKSON PENSION.

No. 2 of 1957.

AN ACT to amend "The *Albert Henry Jackson Pension Act 1931*" and to repeal the *Albert Henry Jackson Pension Act 1951*.

[3 April 1957.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—(1) This Act may be cited as the *Albert Henry Jackson Pension Act 1957*. Short title and citation.

(2) "The *Albert Henry Jackson Pension Act 1931*", as subsequently amended, is in this Act referred to as the Principal Act.

**2**—(1) Section two A of the Principal Act is repealed.

Repeal.

(2) The *Albert Henry Jackson Pension Act 1951* is repealed.

**3** After section one of the Principal Act the following section is inserted:—

"1A—(1) In this Act, 'basic wage for Hobart' means— Interpretation.

I The sum of twelve pounds twelve shillings a week:  
or

II Such other sum as may be fixed and declared pursuant to subsection (2) of this section.

(2) If at any time it appears to the Governor that the basic wage for Hobart, as determined pursuant to the provisions of the *Conciliation and Arbitration Act 1904-1956* of the Commonwealth has been altered (whether by way of increase or decrease) the Governor may, by order, fix and declare, as and to be the basic wage for Hobart for the purposes of this Act, such sum per week as may be necessary in order to ensure that the rate of the pension payable under this Act to *Albert Henry Jackson* is equivalent to the rate of that wage for the time being, and any sum so fixed and declared shall be deemed to be the basic wage for Hobart for the purposes of this Act as if it were expressly prescribed as such in this Act."

**4** Section two of the Principal Act is amended by omitting from subsection (1) the words "an annual pension of three hundred and twenty-five pounds" and substituting therefor the words "a pension at a rate per week equal to the rate of the basic wage for Hobart".

## RADIOACTIVE SUBSTANCES.

No. 3 of 1957.

AN ACT to amend the *Radioactive Substances Act* 1954. [3 April 1957.]

**B**E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title  
and citation.

**1**—(1) This Act may be cited as the *Radioactive Substances Act* 1957.

(2) The *Radioactive Substances Act* 1954 is in this Act referred to as the Principal Act.

Interpreta-  
tion.

**2** Section two of the Principal Act is amended by inserting after the definition of "radioactive substance" the following definitions:—

" 'radiographer' means a person who is a radiographer as defined in the articles of association of the body known as the Australasian Institute of Radiography;

" 'registered veterinary surgeon' means a registered veterinary surgeon as defined in the *Veterinary Act* 1918;"

Exemptions.

**3** Section six of the Principal Act is amended—

(a) by omitting from subsection (1) the words "or a certified dentist" and substituting therefor the words ", a certified dentist, or a radiographer";
