SCHEDULE 1

AMENDMENT OF ACTS

AN ACT to amend the Audit Act 1918, the Acts Interpretation Act 1931, and the Constitution Act 1934 consequential upon the enactment of the Public Account Act 1986 and to repeal the Consolidated Revenue Fund Act 1873.

[Royal Assent 20 May 1986]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the Consolidated Fund (Miscel-Short title. laneous Amendments) Act 1986.

2—This Act shall commence on 1st July 1986.

Amendment of Acts.

3—The Acts specified in Schedule 1 are amended in the manner specified in that Schedule.

Repeal of Consolidated Revenue Fund Act 1873. 4—The Consolidated Revenue Fund Act 1873 is repealed.

SCHEDULE 1

Section 3

AMENDMENT OF ACTS

Acts Interpretation Act 1931

(22 Geo. V No. 59)

- 1—Section 45 is amended as follows:—
 - (a) by omitting the definition of "Consolidated Revenue" and substituting the following definition:—
 - "the Consolidated Fund" or "the General Revenue" means the Consolidated Fund of the State;
 - (b) by omitting "Revenue" from the definition of "financial year" and substituting "Fund";
 - (c) by omitting the definition of "Loan Fund";
 - (d) by omitting the definition of "Trust Fund" and substituting the following definitions:—
 - "the Public Account" means the Public Account of the State established under the Public Account Act 1986;
 - "the Special Deposits and Trust Fund" means the fund of that name established under the *Public Account Act* 1986.

Audit Act 1918

(9 Geo. V No. 3)

- 1—Section 9 (3) is amended by omitting "Revenue" and substituting "Fund".
- 2—Section 15 (1) is amended by omitting "Revenue, loan moneys, trust and deposit accounts," and substituting "Fund and the Special Deposits and Trust Fund,".
- 3—Section 16 is amended by omitting "Revenue" and substituting "Fund".
 - 4—Section 17 is amended as follows:—
 - (a) by omitting from subsection (1) (c) "recurrent";
 - (b) by omitting from subsection (2) "Revenue" and substituting "Fund".
 - 5—Section 28 is repealed and the following section is substituted:—
 - 28—The Treasurer shall, within one month after the expiration of quarterly every quarter of a financial year, cause to be published in the Gazette statements of a detailed statement of the receipts and expenditure within Tasmania expenditure of of the Consolidated Fund during that year up to and including the end Fund.

- 6-Section 29 (1) is amended as follows:-
 - (a) by omitting from paragraph (b) "Revenue" and substituting "Fund":
 - (b) by omitting from paragraph (c) "Revenue for the year, classified and arranged under the same divisions, subdivisions, and items of subdivisions" and substituting "Fund for the year, arranged under the same divisions and items".

7—Section 32A (4) is amended by omitting "Revenue" and substituting "Fund".

8—Schedule II is amended as follows:—

- (a) by omitting from regulation 30 (4) (c) "Public Account Act 1957" and substituting "Public Account Act 1986";
- (b) by omitting from regulation 30 (15) (a) "Revenue" and substituting "Fund";
- (c) by omitting from regulation 43A (1) "within the meaning of section 5 of the *Public Account Act* 1957" and substituting "as mentioned in section 5 of the *Public Account Act* 1986";
- (d) by omitting from regulation 43A (2) (c) "section 9 of the Public Account Act 1957" and substituting "section 12 of the Public Account Act 1986".

9-Schedule III is amended as follows:-

- (a) by omitting from regulation 12 "Revenue" and substituting "Fund";
- (b) by omitting from regulation 13 "Revenue" and substituting "Fund".

Constitution Act 1934

(25 Geo. V No. 94)

- 1—Section 36 is amended by omitting the definition of "Appropriation Act" and substituting the following definition:—
 - "Appropriation Act" means an Act which authorizes the issue and application of any money from the Consolidated Fund to meet—
 - (a) the cost of the ordinary annual services of the Government;
 - (b) expenditure on public works or any property required for public purposes; or
 - (c) the making of a loan authorized by law.

2-Section 37 is amended as follows:-

1986

- (a) by omitting from subsection (1) "part of the revenue or of any moneys" and substituting "money";
- (b) by omitting from subsection (2) "part of the revenue or of any moneys" and substituting "money".
- 3—Section 38 (1) is amended by omitting "part of the revenue or of any moneys," and substituting "money".
- 4—Section 39 is amended by omitting paragraph (a) and substituting the following paragraph:—
 - (a) deal with any matter other than the issue, application, and appropriation of money out of the Consolidated Fund; or
- 5—Section 40 (a) is amended by omitting "moneys out of the revenue" and substituting "money out of the Consolidated Fund".
- 6—Section 42 is amended by omitting subsection (1) and substituting the following subsection:—
 - (1) The Council may not amend—
 - (a) a provision of a Bill for an Appropriation Act that authorizes the issue and application of any part of the revenue or other money from the Consolidated Fund to meet the cost of the ordinary annual services of the Government;
 - (b) a Bill for an Income Tax Rating Act; or
 - (c) a Bill for a Land Tax Rating Act.
