Short title

1—This Act may be cited as the Consolidated Fund Appropriation Act (No. 2) 1992-1993.

Commencement

2-This Act commences on the day on which it receives the Royal Assent.

Issue, application and appropriation of \$35 000 000

3-(1) In respect of the financial year ending on 30 June 1993, the Treasurer may-

- (a) issue the sum of \$35 000 000 out of the Consolidated Fund; and
- (b) apply that sum for the services of the Government.

(2) The sum specified in subsection (1) is appropriated.

Purpose of appropriation

4-(1) As shown by Schedule 1, the total of the sum appropriated by section 3 of the Consolidated Fund Supply Act 1992-1993, the sum appropriated by section 3 of the Consolidated Fund Appropriation Act 1992-1993 and the sum appropriated by section 3 of this Act is \$1 582 557 000.

(2) The sum of \$35 000 000 appropriated by section 3 is to be applied for the purpose specified in Schedule 2.
