

## CENSORSHIP OF FILMS.

### No. 6 of 1949.

#### AN ACT to amend the *Censorship of Films Act* 1947. [12 April, 1949.]

**B**E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—(1) This Act may be cited as the *Censorship of Films Act* 1949. Short title and citation.

(2) The *Censorship of Films Act* 1947\* is in this Act referred to as the Principal Act.

**2** Section three of the Principal Act is amended by adding at the end thereof the following definition:— Interpretation.

“‘the Board’ means the Cinema Registration Board established by the regulations made under authority of paragraph (e) of subsection (3) of section twenty-seven of the *Places of Public Entertainment Act* 1917†.”

**3** Section twenty-six of the Principal Act is amended by omitting the words “every person who carries on the business of exhibiting cinematograph pictures in theatres, and”. Exhibitors of and dealers in films to register.

**4** Section thirty-one of the Principal Act is amended— Under-Secretary's certificate to be *prima facie* evidence that distributor or exhibitor has not registered.

(a) by omitting therefrom the words “, or an exhibitor of cinematograph pictures,”;

(b) by omitting the word “Under-Secretary” and substituting therefor the words “chairman of the Board”;

(c) by omitting the words “or exhibitor, as the case may be,”.

**5** Section thirty-three of the Principal Act is amended by omitting therefrom the words “for registration as an exhibitor of cinematograph pictures, or”. No fees payable in respect of charitable, &c., entertainments.

**6** Section thirty-four of the Principal Act is amended— Regulations.

(a) by omitting in paragraph (b) the words and symbols “—(i) of exhibiting cinematograph pictures in theatres; or (ii)”;

(b) by inserting after paragraph (b) the following paragraph:—

“(ba) the fees payable in respect of the registration of persons carrying on the classes of business referred to in paragraph (b);”.

Fees.

**7** The schedule to the Principal Act is amended by omitting paragraph 2 thereof and substituting therefor the following paragraph:—

“2. On appeal by any person aggrieved by any decision of the censor—

(a) In respect of a film submitted for approval—for every reel of such film or part thereof (with a minimum fee of one pound ten shillings for any one film) 0 10 0

(b) In respect of any advertisement—for every sample copy (with a minimum fee of one pound ten shillings in respect of every sample copy in respect of any one film) ..... 0 10 0”.

## McDONALD PENSION.

No. 7 of 1949.

AN ACT to provide for the Payment of a Pension to *Mary McDonald*, widow of the Honourable *James McDonald*, a former Minister of the Crown of this State. [12 April, 1949.]

**B**E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1** This Act may be cited as the *McDonald Pension Act* 1949.

Short title.
