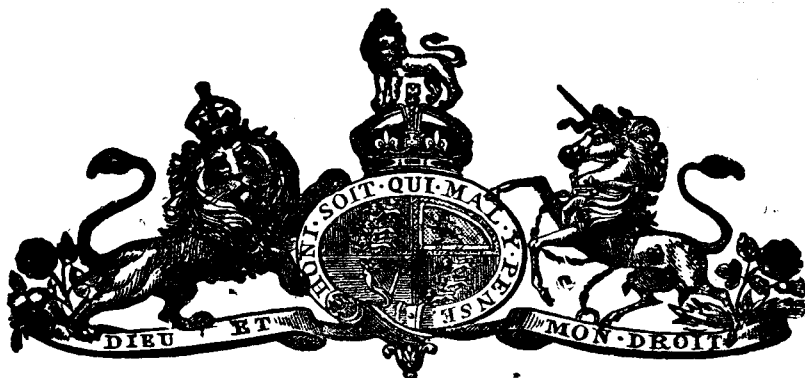

 AN ACT to amend the *Hobart Corporation Acts 1929-33.* [13 December, 1934.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

- 1**—(1) This Act may be cited as the *Hobart Corporation Act 1934.*
 (2) The *Hobart Corporation Acts 1929-33*, as amended by this Act, may be cited as the *Hobart Corporation Acts 1929-1934.*

2 The *Hobart Corporation Act 1929* is hereby amended as follows:—

I. As to section eight thereof, by inserting the word "Lord" before the word "Mayor" in the third line thereof:

II. As to section forty-two thereof, by deleting the words "Deputy Town Clerk" in the third and fourth lines and in the fifth line respectively of subsection (3) and substituting therefor the words "Chief Clerk in the Town Clerk's Office," and such words shall be substituted for the like words wherever occurring in any Act, by-law, or regulation: and

III. By inserting after section one hundred and fifty-eight A the following new section—

"**158B** It shall be lawful for the Council to appropriate and expend out of the revenues of the Corporation the following sums of money for the respective purposes hereinafter set forth:—

(1) As a contribution towards the Southern Tasmanian Anti-Cancer Campaign Fund, not exceeding £250

(2) As a contribution towards the payment of one half of the costs of the construction and erection of the works and electrical installation connected with the permanent illumination of the War Memorial Cenotaph on the Queen's Domain, not exceeding £150

3 The *Hobart Corporation Act 1930* is hereby amended—

I. As to section seventy-one thereof—

(a) By inserting the figure (1) at the beginning thereof: and

(b) By adding at the end thereof the following new subsection (2):—

"(2) If any such owner as aforesaid shall sell or transfer, or contract to sell or transfer, the whole or any portion of such lands, houses, or buildings as aforesaid, then the owner for the time being of the lands, houses, or buildings so sold or transferred, or contracted to be sold or transferred, shall be liable to pay such proportion of the interest upon such cost as may appear to the Council to

be just and equitable, and the proportion of the interest so payable as aforesaid may be recovered in the same manner and by the same process as any city rate.” :

- II. By inserting after section one hundred and five the following new section : and New section
105A.

“**105A** The following piece of land situate between High Street, Sandy Bay, and the River Derwent is hereby constituted a city recreation ground and shall be known by the name of ‘The High Street Reserve’ :—

HIGH STREET RESERVE.

2 ROODS 32 PERCHES.

All that piece of land situate in the City of Hobart containing 2 roods 32 perches and bounded as follows :— Commencing at the most western corner of property owned by *Robert Walpole* on Sandy Bay Road thence north-westerly along the north-eastern boundary of the Sandy Bay Road for 799 links thence north-easterly for 40 links to the high-water mark of the River Derwent thence south-easterly in several bearings along the said high-water mark for 822 links or thereabouts to the most northern corner of the said property owned by *Robert Walpole* thence south-westerly along the north-western boundary of that property for 244 links to the point of commencement.”
