HOBART CORPORATION.

No. 17 of 1961.

AN ACT to amend the Hobart Corporation Act 1947. [7 September 1961.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

54

- 1—(1) This Act may be cited as the *Hobart Corporation* Act 1961.
- (2) The Hobart Corporation Act 1947, as subsequently amended, is in this Act referred to as the Principal Act.

Returning officer or assistant returning officer at each polling-place: Time for voting.

- 2 Section forty-one of the Principal Act is amended—
 - (a) by omitting from subsection (3) the word "nine" and the word "seven" (wherever occurring) and substituting therefor, in each case, the word "eight"; and
 - (b) by inserting in that subsection, after the word "o'clock" (third occurring), the words "in the afternoon".

Construction of new private streets.

- **3** Section one hundred and eighty-three of the Principal Act is amended—
 - (a) by omitting paragraphs I and II of subsection (1) and substituting therefor the following paragraphs:—
 - "I The owner under the supervision of the council's engineer: or
 - "II The council at the cost of the owner either at his request or on his failure so to construct in accordance with the provisions of this subsection,";
 - (b) by omitting from that subsection the words "date of the notification" and substituting therefor the words "receipt by him";
 - (c) by inserting in that subsection, after the word "approval", the words "under subsection (6) of section one hundred and eighty-one"; and
 - (d) by adding at the end of that subsection the words "and if that street has been constructed by the council the council may, without prejudice to its rights of recovery or of other action and without

first taking any action against the owner, recover the cost so involved from any guarantor or from any moneys or other security deposited with it in respect of the construction of that street.".

4 Section two hundred and four of the Principal Act is Sources of amended by inserting after subsection (2) the following subsection:—

- "(2A) The council may buy water from the Rivers and Water Supply Commission for the purposes of this Act and of the West Derwent Water Act 1951, and may supply water to that Commission on and in accordance with such terms and conditions as may be agreed upon between them.".
- **5** Section three hundred and thirteen of the Principal Act Restriction is amended by adding at the end thereof the following subsecultion:—
- "(6) Notwithstanding the provisions of subsection (1) of this section, the council may alienate and transfer one rood twenty-nine and nine-tenths perches of land contained in Purchase Grant Volume 251 Folio 1 registered in the office of the Recorder of Titles, freed and discharged from the provisions of this Act, to the trustees for the time being of Bayly's Estate in exchange for two areas of ten and six-tenths perches and one rood eighteen and eight-tenths perches respectively, more particularly shown on Plan No. 421/15 deposited with the Recorder of Titles, which are required for the purpose of improving the outlet of the New Town Rivulet to New Town Bay."
- 6 The fifth schedule to the Principal Act is amended by The After adding at the end thereof the following items:—

"(zn)	The provision of off-street parking areas or buildings	£500,000
"(zo)	The provision of land, premises, and equipment for reserves, recreation grounds, and public swimming pools with such equipment, furniture, and other facilities as the council thinks fit and the improvement thereof	£250,000
"(zp)	Augmenting, improving, and extending the sewerage system of the city, providing sewage treatment plants, and generally for the purposes of Part XII of the <i>Hobart Corporation Act</i> 1947	£500,000
"(zq)	Constructing, reconstructing, improving, extending, realigning, and widening the streets of the city	£600,000
"(zr)	Augmenting, improving, and extending the water supply of the city and suburbs, the improvement and extension of the reticulation therein, and generally for the purposes of Part XI of the Hobart Corporation Act 1947	£500,000
