- (2) The Transport Act 1938, as subsequently amended, is in this Act referred to as the Principal Act.
 - 2—(1) Section nineteen of the Principal Act is amended—

Revenue of the Commission.

- (a) by omitting paragraph (i) of subsection (1); and
- (b) by omitting subsection (2).
- (2) This section does not apply to any moneys received by the Treasurer, by way of land tax, before the first day of July 1969.
- 3 Section twenty A of the Principal Act is amended by omitting Treasury advances to Subsection (5).
 - 4 Section twenty-four of the Principal Act is amended—

Commission to pay interest on loans.

- (a) by omitting from subsection (1) the words "section twenty" and substituting therefor the words "section twenty A or section twenty B"; and
- (b) by omitting from paragraph (b) of subsection (2) the words "section twenty" and substituting therefor the words "section twenty A or section twenty B".
- 5 Section twenty-six of the Principal Act is amended—

Annual accounts.

- (a) by adding at the end of sub-paragraph (vi) of paragraph(c) of subsection (1) the word "and";
- (b) by omitting sub-paragraph (vii) of that paragraph; and
- (c) by omitting from paragraph (b) of subsection (3) the words "by paragraph I of" and substituting therefor the word "under".
- 6 The Commission shall repay to the Treasurer all moneys paid by Repayment by him to the Commission under subsection (2) of section nineteen of of land the Principal Act as moneys received by him after the thirtieth day of tax received June 1969 by way of land tax; and any moneys so paid or repaid June 1969. shall be disregarded for the purposes of preparing the accounts required to be prepared under section twenty-six of the Principal Act.

INFLAMMABLE LIQUIDS.

No. 16 of 1970.

AN ACT to amend the *Inflammable Liquids Act* 1929. [18 June 1970.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Inflammable Liquids Act* Short title and citation

(2) The *Inflammable Liquids Act* 1929, as subsequently amended, is in this Act referred to as the Principal Act.

Regulations.

- 2 Section sixteen of the Principal Act is amended—
 - (a) by inserting in paragraph (d) of subsection (1), after the word "conveying", the words ", or in the distribution or use,";
 - (b) by inserting after that paragraph the following paragraph:—
 - "(da) the precautions to be observed, the methods to be employed, and the requirements to be complied with, in or in connection with the installation, in or on buildings, vessels, and vehicles, of equipment or apparatus of any prescribed kind that is designed for containing or supplying any prescribed kind of inflammable liquid or dangerous commodity and the precautions to be observed in relation to the use in or on buildings, vessels, or vehicles, of any such equipment, apparatus, liquid, or commodity;"; and
 - (c) by inserting after paragraph (b) of subsection (2) the following paragraph:—
 - "(ba) prohibit—
 - (i) the installation, in or on buildings, vessels, and vehicles, of any prescribed kind of equipment or apparatus for containing or supplying any inflammable liquid or dangerous commodity, or any prescribed kind of inflammable liquid or dangerous commodity, or the alteration or repair of any such equipment or apparatus; or
 - (ii) the sale, supply, or distribution of any such liquid or commodity,

except by persons who hold a subsisting licence of a prescribed kind issued under the regulations or a subsisting licence or certificate of registration of a prescribed kind issued under an Act other than this Act;".
