AN ACT to amend the *Motor Vehicles Tax Act* 1917. [6 December, 1937.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled. as follows :—

1 This Act may be cited as the *Motor Vehicles Tax Act* short title. 1937.

Payment of tax by instalments. 2 The Principal Act is hereby amended—

- I. By inserting "except as provided by section five" (after "and" in subsection (2) of section four thereof):
- II. By substituting for repealed section five thereof the following new section five-

"5-(1) Where the tax payable by any person under section four amounts to or exceeds four pounds, such person may pay one-half of such tax on registration and the balance, together with an additional sum of not more than one twentieth of the second instalment added, not later than six months from the date of such registration.

"(2) The amount of such balance and additional sum so unpaid shall be a debt due to His Majesty, and shall be a charge on the vehicle in respect of which it is payable, and such charge may be enforced as prescribed by the Registrar by warrant in the prescribed form authorising the seizure and sale of such vehicle at any time after the expiration of the said period of six months.":

III. By inserting "an officer in charge of any branch office of the Tasmanian Government Tourist Bureau or the chief clerk of such officer" (after "teacher" in section thirteen thereof):
