AN ACT to amend the Cecilia Button Memorial Hospital Agreement Act 1946. [20 April, 1953.]

HEREAS by his will dated the seventh day of February Preamble. 1933 (in this Act referred to as "the will") Henry Edwin Button directed his trustees to found for the benefit of the people of the municipality of Oatlands a hospital to be known as "The Cecilia Button Memorial Hospital" and to apply certain moneys in or towards the erection and equipment of a suitable hospital and in the maintenance of that hospital, and set forth certain provisions and conditions relating to the establishment and maintenance of that hospital:
