AN ACT to amend the *Transport Act* 1938. [20 November 1964.]

B^E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

1-(1) This Act may be cited as the *Transport Act* 1964.

(2) The Transport Act 1938, as subsequently amended, is in this Act referred to as the Principal Act.

Accounts of Transport Commission.

Annual report and accounts. 2 Section thirty of the Principal Act is amended—

- (a) by omitting from subsection (1) all the words following the word "him"; and
- (b) by omitting subsection (2).

3 Section forty of the Principal Act is repealed and the following section is substituted therefor:—

"40—(1) As soon as practicable after the end of each financial year the Commission shall furnish to the Minister a report of the operations, business, and affairs of the Transport Department in respect of that financial year and a copy of the accounts for that financial year required to be submitted to the Auditor-General under section thirty.

"(2) The Minister shall lay before each House of Parliament a copy of the report and accounts referred to in subsection (1) of this section within the first ten sitting days of that House after the receipt by him of that report and a copy of those accounts.".

HOSPITALS.

AN ACT to amend the Hospitals Act 1918. [20 November 1964.]

B^E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:---

Short title and citation.

1—(1) This Act may be cited as the Hospitals Act 1964.

Hospitals.

(2) The Hospitals Act 1918, as subsequently amended, is in this Act referred to as the Principal Act.

2 Section twenty-five of the Principal Act is amended by Vacation of office by office by office by (g) of subsection (1) thereof and sub- member of board. stituting therefor the following paragraph:-

> "(g) he fails, for a period of two months or more, to attend meetings of the board without leave granted by the board, with the Minister's approval;".

TRAFFIC.

AN ACT to amend the *Traffic Act* 1925. [20 November 1964.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :---

1-(1) This Act may be cited as the Traffic Act 1964.

(2) The Traffic Act 1925, as subsequently amended, is in ment. this Act referred to as the Principal Act.

(3) This Act shall commence on the date on which the Stamp Duties Act 1964 commences.

2 Section seventy-six of the Principal Act is amended- Over-

- (a) by omitting therefrom the word "No" and substi- prohibited tuting therefor the words "Subject to subsection (2) of this section, no"; and
- (b) by adding at the end thereof the following subsection :---

"(2) This section does not prohibit an insurer from demanding and receiving from a person by whom a policy issued in accordance with this Part is effected any sum that may be payable, by virtue of the provisions of the Stamp Duties Act 1931, by way of duty in respect of a certificate of insurance delivered by the insurer to that person pursuant to subsection (4) of section sixty-four of this Act.".
