**AN ACT to amend the Traffic Act 1925 for the purpose of making provision for an increase in the fees payable under that Act and for other purposes.**

[Royal Assent 26 November 1980]

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—This Act may be cited as the *Traffic Amendment Act (No. 3)* Short title.  
1980.

**2**—(1) This Act shall commence on 1st December 1980. Commencement.

(2) Before the commencement of this Act, regulations may be made under the Principal Act, as amended by this Act, as if section 4 of this Act had commenced, but those regulations do not take effect until that section commences.

Principal Act. **3**—In this Act, the *Traffic Act 1925\** is referred to as the Principal Act.

Amendment of section 10 of Principal Act (Regulations: Application to the Crown). **4**—Section 10 (1) of the Principal Act is amended by inserting the following paragraph after paragraph (f):—

(g) providing for the payment of a fee for the testing of a person's ability to operate and drive in a safe manner a motor vehicle of the class with respect to which the licence is applied for;

Amendment of Schedule 2 to Principal Act. **5**—Schedule 2 to the Principal Act is repealed and the following Schedule is substituted:—
