AN ACT to amend the Traffic Act 1925.

[Royal Assent 27 November 1987]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Traffic Amendment Act* Short title. (No. 3) 1987.

2—This Act shall commence on 1st December 1987. Commencement.

Principal Act.

3—In this Act, the *Traffic Act 1925\** is referred to as the Principal Act.

Amendment of section 10 of Principal Act (Regulations).

4—Section 10 (4) of the Principal Act is amended by omitting “6/18th” and substituting “6/28th”.

Substitution of Schedule 2 to Principal Act.

5—Schedule 2 to the Principal Act is repealed and the following Schedule is substituted:—

Transitional provisions.

6—(1) Where an application for the registration, renewal of registration, or transfer of registration of a vehicle is made on or before 1st December 1987, and the registration, renewal of registration, or transfer of registration, if done, would not be effective until that date or a later date, the fees prescribed by virtue of the substitution of Schedule 2 to the Principal Act by this Act shall have effect in relation to that application as if the fees prescribed by virtue of the substitution had taken effect.

(2) The amount that the Commission shall be required to pay to the Treasurer in accordance with section 10 (4) of the Principal Act for the financial year ending on 30th June 1988 shall be the aggregate of—

- (a)  $\frac{6}{18}$ th of the total amount received by the Commission by way of fees for the matters referred to in that subsection for the period 1st July 1987 to 30th November 1987; and
- (b)  $\frac{6}{28}$ th of the total amount received by the Commission by way of fees for the matters referred to in that subsection for the period 1st December 1987 to 30th June 1988.
