AN ACT to amend "The Animals' and Birds' 1920. Protection Act, 1919." [24 December, 1920.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as "The Animals' and Birds' Protection Short title and Act, 1920," and shall be incorporated with and construed as one with incorporation "The Animals' and Birds' Protection Act, 1919," in this Act referred with 10 Geo. V. to as "the Principal Act."

#### Animals' and Birds' Protection.

Amendment of Section 9 of Principal Act. 2 Section Nine of the Principal Act is amended by inserting after Paragraph viii. thereof the following new paragraph:—

"viiia. Transfer any animal or bird from either the First, Second, or Third Schedules to another of the said Schedules; or add the name of any animal or bird to any Schedule; or amend any Schedule."

Amendments of Sections 19 and 21 of Principal Act. 3 Paragraph (1) of Section Nineteen and Subsection (2) of Section Twenty-one of the Principal Act are hereby amended by deleting therefrom the word "fenced."

Amendment of Section 24 of Principal Act. 4 Section Twenty four of the Principal Act is hereby amended by adding after the word "royalties" in the Second line thereof the words "in respect of such areas or districts."

Amendment of Section 26 of Principal Act.

5 Paragraph x1. of Subsection (1) of Section Twenty-six of the Principal Act is hereby amended by deleting the word "close" in the Fourth line, and substituting the word "open" therefor.

Repeal of Section 31 of Principal Act.

6 Section Thirty-one of the Principal Act is hereby repealed, and the following substituted therefor:—

"31 In any prosecution for an offence under Section Fifteen or Section Twenty-one of this Act, the onus shall be upon the person charged to prove that any animal, bird, carcase, skin, gun, or eggs proved to have been in his possession were lawfully taken, sold, bought, obtained, or exported by him, or lawfully in his possession or control."

Amendment of Part I. of Second Schedule and Part I. of Third Schedule of Principal Act.

Amendment of Part II. of Second Schedule of Principal Act. 7 Part I. of the Second Schedule of the Principal Act is hereby amended by omitting therefrom the words "Kangaroo Rats (all species)," and re-inserting the said words at the end of Part I. of the Third Schedule of the Principal Act.

8 Part II. of the Second Schedule of the Principal Act is hereby amended as follows:—

a. By striking out in the Eighth line thereof, the word "last" and substituting therefor the word "Fourteenth."

II. By striking out the words "Quail of every species and" in the last line but one of the First column of the said part of the said schedule:

III. By inserting at the end of the said part of the said schedule in the First column thereof the words "Quail of every species", and in the Second column thereof "From First July in each year to Thirtieth April of the following year (both dates included)."
