TOURIST AND IMMIGRATION DEPARTMENT (ADELAIDE OFFICE PURCHASE).

No. 1 of 1955.

AN ACT to authorize the purchase by the State of certain premises in the city of Adelaide for the purposes of the *Tourist and Immigration Department Act* 1934, and the borrowing of a sum not exceeding £52,000 for that purpose. [11 May, 1955.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1—(1) This Act may be cited as the Tourist and Immigra-short title tion Department (Adelaide Office Purchase) Act 1955.
- (2) This Act is incorporated, and shall be read as one, with the *Tourist and Immigration Department Act* 1934 (in this Act referred to as the Principal Act).

Tourist and Immigration Department (Adelaide Office Purchase).

Power to purchase premises in Adelaide.

- **2**—(1) For the purposes of the Principal Act, the Minister may purchase, for and on behalf of Her Majesty, the premises situated at number 32A King William Street in the city of Adelaide, in the State of South Australia, at a price not exceeding £50,000.
- (2) The premises to which this section applies shall be conveyed or transferred to, and be held by, such person on behalf of Her Majesty as the Minister directs.
- (3) The premises to which this section applies shall be used for the purposes of the Principal Act and such other purposes as the Minister directs, and, subject to the supervision of the Minister, shall be under the control and management of the Director.
- (4) The Minister may let to any person any portion of the premises to which this section applies, which is not required for the purposes of the Principal Act, on such terms and conditions as he thinks fit.

Power of Minister to expend money alterations.

- 3 The Minister may expend such sum, not exceeding £2000, as he thinks necessary for all or any of the following purposes, namely:-
 - (a) In making such alterations or additions to the premises referred to in section two as are, in his opinion, required to enable them to be used for the purposes of the Principal Act;
 - (b) In or in connection with the purchase, and installation in those premises, of such furniture, equipment, and fittings as are, in his opinion, required to enable the premises to be used for the purposes of the Principal Act: and
 - (c) In defraying any costs and expenses incidental to the purchase of those premises.

Borrowing powers.

- 4—(1) The Treasurer may arrange for the borrowing, in accordance with the Financial Agreement, of a sum of money not exceeding £52,000 for the purposes of this Act.
- (2) In this section, "Financial Agreement" means the agreement made between the Commonwealth and the States and ratified by the Financial Agreement Act 1927, and includes that agreement as varied from time to time and any agreement made in substitution therefor.
