

AN ACT to regulate the Payment of certain Moneys in Aid of Road Rates, and for other purposes. [17 December, 1912.]

A.D. **1912.**

DE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited as "The Aid to Road Rates Act, 1912."

Short title.

Aid to Road Rates.

Subsidies in aid of road rates payable to councils which have levied general road rates not less than One Shilling in the pound.

2 There shall be payable by the Treasurer of the State in the financial year ending the Thirtieth day of June, One thousand nine hundred and thirteen, subsidies in aid of road rates, and subject to the provisions of Section Five of this Act the same shall be paid out of the sum of Thirteen thousand Pounds authorised by "The Appropriation Act, 1912-13," to be issued by the Treasurer out of the Consolidated Revenue, and by that Act appropriated for "Aid to Road Rates"; and such subsidies shall, subject as hereinafter provided, be payable to the municipal councils of all municipalities constituted under "The Local Government Act, 1906," and mentioned in the schedule hereto, which have levied a general road rate of not less than One Shilling in the pound on the annual value of the ratable property within the municipality for the year ending the Thirty-first day of December, One thousand nine hundred and twelve.

How amount of subsidy calculated and determined.

Conditions.

3 The amount of the subsidy payable to each of the said councils shall be calculated and determined as hereinafter provided, and such amount shall be payable upon and subject to the following conditions :--

> 1. The Minister for Lands and Works shall determine the amount of subsidy payable to each of the said councils, and the amount payable shall be the sum produced by multiplying the total annual value of ratable properties within the municipality by the rate in the pound set opposite the name of the municipality in the schedule.

Provided that if the sum to be applied in payment of the said subsidies under this Act shall be insufficient to pay the amount of each subsidy in full, a proportionate reduction or abatement shall be made in the amounts of the said subsidies :

- II The total annual value of the property within a municipality shall be ascertained from the assessment rolls in force in the municipality for the year One thousand nine hundred and twelve:
- III. Every subsidy shall be payable by such instalments, and at such times and subject to such conditions, as the Minister for Lands and Works shall from time to time determine :
- v If any doubt or difficulty arises in connection with the allocation or payment of the subsidies, the same shall be settled by the Minister for Lands and Works, and his decision shall be final.

4 The subsidy payable to a council shall be expended and applied by the council in or towards the construction, repair, and maintenance of roads, streets, bridges, and jetties; and in any case where the Minister, on the recommendation of the Engineer-in-Chief, informs the council that any important road requires maintaining or repairing, the council shall expend the subsidy, or a sufficient part thereof, in maintaining or repairing such road; and in the event of the council

neglecting or refusing to do so, it shall be lawful for the Minister, with A.D. 1912. the consent of the Governor, to retain so much of the subsidy remaining unpaid as he thinks necessary for the purpose, and to expend the same in repairing or maintaining the road.

5 Before payment of the said subsidies the Treasurer of the State Certain sums (out shall issue and pay to the Minister for Lands and Works, out of the of vote) amountsaid sum of Thirteen thousand Pounds, the following sums, to be applied ing to £2750 t by that Minister for the following purposes, namely :----

1. The sum of Five hundred Pounds to be applied—

- (a) In the first place, in or towards any necessary repairs and maintenance in respect of the Sorell Causeway and the bridge across the River Derwent at Bridgewater, and the approaches thereto respectively, and subject thereto;
- (b) In or towards any necessary repairs and maintenance in respect of roads, streets, and bridges generally:
- II. A further sum of Two hundred and fifty Pounds to be applied in or towards any work the Minister approves in respect of the Stony Rise-road, carried out by the Municipal Council of Devonport :
- 11. A further sum of Two thousand Pounds to be applied, subject to such terms and conditions as the Minister may impose, in or towards repairs and maintenance in respect of roads deemed by the Minister to be main or principal roads.

And the execution of the said repairs and maintenance, pursuant to the provisions of this section, shall be charged upon and paid out of the said several sums of Five hundred Pounds, Two hundred and fifty Pounds, and Two thousand Pounds, which may be appropriated by the Treasurer accordingly.
