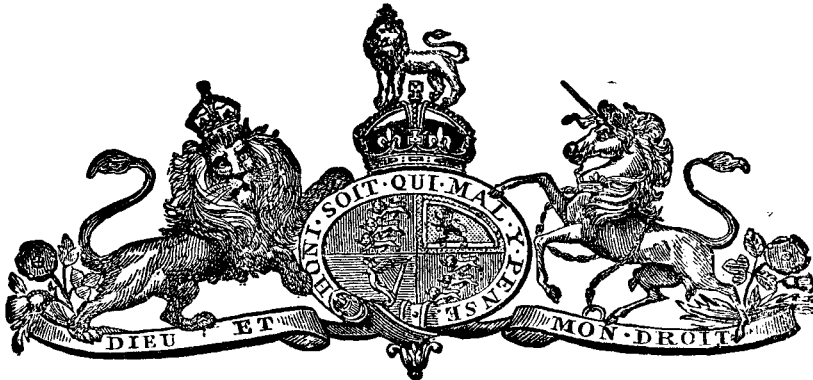

AN ACT to amend the Bills of Sale Act, 1900.  
 [17 September, 1926.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—(1) This Act may be cited as “The Bills of Sale Act, 1926.” Short title.  
 (2) The Bills of Sale Act, 1900, is herein called “the Principal Act.” Principal Act.

**2** Section Nine of the Principal Act is hereby amended by deleting the words “of the maker or giver of such bill of sale” in the second and third lines thereof. Amendmen of

Amendment of  
Section 11 of the  
Principal Act.**3** Section Eleven of the Principal Act is hereby amended as follows :—

- i. By deleting the word "the" in the first line thereof, and substituting the word "any" therefor :
- ii. By inserting the words "or join in the making or giving of" after the word "give" in the second line thereof : and
- iii. By inserting the word "any" after the word "of" where it occurs for the second time in the third line thereof.

Amendment of  
Section 12 of the  
Principal Act.**4** Section Twelve of the Principal Act is hereby amended as follows :—

- i. By inserting the words "or persons" after the word "person" in the second and in the fourth lines thereof :
- ii. By deleting the words "such person" in the eighth line thereof, and substituting the words "any person named in the caveat as being indebted to such caveator" therefor : and
- iii. By deleting the words "the person named in such notice as intending to make or give" in the tenth and eleventh lines thereof, and substituting the words "any person named in such notice as intending to make or give, or join in the making or giving of" therefor.

Principal Act.**5** Section Fourteen of the Principal Act is hereby amended by inserting the words "or persons" after the word "person" in the eighth line thereof.Amendment of  
Section 15 of the  
Principal Act.**6** Section Fifteen of the Principal Act is hereby amended by inserting the words "or persons" after the the word "person" in the fourth line thereof.Amendment of  
Section 16 of the  
Principal Act.**7** Section Sixteen of the Principal Act is hereby amended as follows :—

- i. By deleting the word "the" in the third line thereof, and substituting the word "any" therefor :
- ii. By inserting the words "or join in the making or giving of" after the word "give" in the fourth line thereof : and
- iii. By inserting the words "or persons" after the word "person" in the ninth line thereof.

Amendment of  
Schedule (2) to  
the Principal Act.**8** Schedule (2) to the Principal Act is hereby amended by inserting the following words at the end thereof :— "Where the notice of intention has been lodged in respect of a bill of sale to be made or given by two or more persons jointly, and the debt or debts in respect of which the caveat is entered is or are owing by only one of such persons, or by any number less than the whole number of such persons, the form shall be altered to show by which of such persons the debt or debts is owing."
