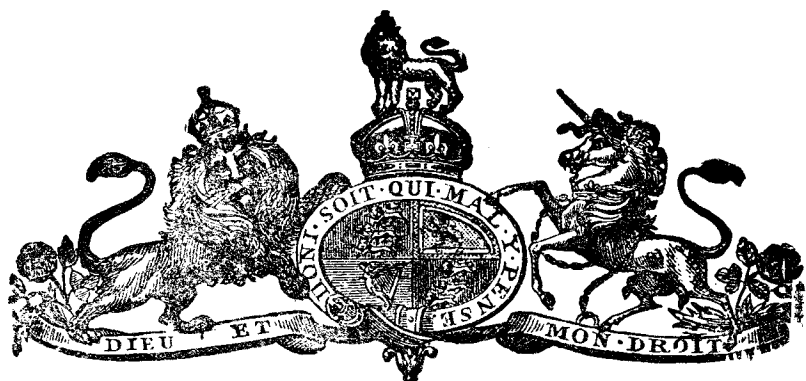

AN ACT to authorise the Warden, Councillors,
and Electors of the Municipality of Emu Bay
to borrow a Further Sum of Twenty-five
thousand Pounds, and for other purposes.

WHEREAS the Council of the Municipality of Emu Bay is
desirous of borrowing a further sum of Twenty-five thousand Pounds
for the purpose of increasing and improving the supply of water for the
use of the inhabitants of the Town of Burnie and contiguous districts :

Preamble.

Be it therefore enacted by His Excellency the Governor of Tasmania,
by and with the advice and consent of the Legislative Council and
House of Assembly, in Parliament assembled as follows :—

1 This Act may be cited as “The Burnie Water Act, 1928.”

Burnie Water.

Interpretation.
- 2** In this Act, unless inconsistent with the context—
 “The Corporation” means the Warden, councillors, and electors of the Municipality of Emu Bay :
 “The Council” means the Municipal Council of the said Municipality :
 “The Loans Act” means the State Loans to Local Bodies Act, 1921 :
 “The said Act” means the Burnie Water Act, 1901 ;
 “The said area” means the Burnie water area described in the schedule hereto.

- Extended operation of the Burnie Water Act, 1901.
- 3** From and after the commencement of this Act, all the provisions of the said Act relating to the Town of Burnie shall, so far as the same are applicable, apply to and in respect of the said area as if the Town of Burnie comprised such area.
- Power to Council to borrow further £25,000.
- 4** Upon the Engineer of Works furnishing to the Minister a favourable report on the proposed work, it shall be lawful for the Council on behalf of the Corporation, in addition to any moneys already borrowed under the said Act, to borrow under the provisions of the Loans Act any sum or sums of money, not exceeding in the whole the sum of Twenty-five thousand Pounds, for the purpose of defraying the cost and expense of, or connected with, installing a supply of water to serve the said area and generally for the purposes of carrying out or extending all or any of the works or objects authorised by the said Act.
- Poll to be taken before borrowing.
- 5**—(1) The Council shall not proceed to borrow any moneys under the authority of this Act until such borrowing has been sanctioned at a poll of electors to be taken by the Council in accordance with the provisions of the Loans Act. Such sanction shall be deemed to have been given if at the taking of such poll more than one-half of the valid votes recorded thereat shall be in favour of the Council proceeding to borrow such moneys.
- (2) The persons qualified to vote at the poll shall be the persons who are qualified, in respect of the said area, to vote at an election of councillors for the Municipality of Emu Bay.
- Rating powers in Principal Act to apply in respect of this Act.
- 6** All rating powers vested in the Council under or by virtue of the said Act shall, in addition to their application under that Act, apply to and in respect of the works to be carried out under this Act, and the moneys to be borrowed therefor as if the same were to be carried out and borrowed for the purposes of the said Act.
- Sinking fund.
- 7** The amount payable by the Council as an annual contribution towards a sinking fund in respect of any moneys borrowed under this Act shall be an amount equal to One Pound Ten Shillings per centum of the moneys so borrowed.

Burnie Water.

8 It shall be lawful for the Treasurer to borrow, raise, and receive a total sum not exceeding Twenty-five thousand Pounds for the purposes of this Act.

SCHEDULE.**THE BURNIE WATER AREA.**

Commence at a point on high-water mark on Bass Strait, being due north of the north-eastern angle of the Quarry Reserve on the Main-road Wivenhoe southerly along the eastern boundary of the Quarry Reserve and Lot No. 4 of Section U Town of Wivenhoe thence by the southern boundary of that Lot to its south-western boundary then southerly along Lot 2 of Section U Town of Wivenhoe to its south-western corner thence along the northern boundary of Section U Lots 3 and 5 to the Stowport-road thence southerly along that road to the corner of Brummell-street westerly along Brummell-street to the Emu River thence westerly from the Emu River to the Emu Bay Railway-line thence along the northern line of the railway to Romaine Creek then southerly along that creek to its junction with Alexander Creek then southerly along Alexander Creek to New Country-road then across that road and going west for a distance of fourteen chains thence northerly in a straight line to Lot 32 of the Van Diemen's Land Company's Emu Bay Estate thence westerly along that line to its south-western corner then northerly along the western boundary of Section 32 to the south-east corner of Lot No. 31B thence along the southern boundary of that lot to Stony Creek then northerly along that creek to the south-western corner of Lot 25 thence along the southern boundary of that lot to the south-west corner of Lot No. 26 thence northerly along the boundary of Lot 26 to the north-western boundary of that lot thence in a north-westerly direction along the southern boundary of Lots 13 and 11 to the View-road thence south-westerly along that road to its junction with Mooreville-road thence northerly along that road to the south-east corner of Lot No. 7A on Oldaker's Estate Subdivision thence along the southern boundary of that lot to its south-west corner then in a northerly direction along the eastern boundary of Lot No. 10 of the Van Diemen's Land Company's Subdivision to a point eight chains southerly from the main road thence westerly in a parallel line with the main road eight chains south of that road to the western boundary of the north ward of the Municipality of Emu Bay thence southerly along that line to the south-eastern corner of land owned by J. R. Blyth thence along the southern boundary of that land to its south-western boundary thence northerly along the western boundary of J. R. Blyth's lot to Fidler-street thence along that street to the main road thence northerly by Bass Strait to the point of commencement.
