

AN ACT to amend "The Customs Duties A.D. 1893. Act, 1892." [6 November, 1893.]

WHEREAS it is expedient to impose further Duties of Customs: PREAMBLE. Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

1 This Act may be cited as "The Customs Duties Amendment Short title. Act, 1893."

2 In this Act the expression "the said Act" means "The Customs Interpretation. 56 Vict. No. 16. Duties Act, 1892."

3-(1.) On and after the Twenty-seventh day of July, One thousand Primage Duty of eight hundred and ninety-three, and until the Eighth day of September, 1 per cent. on One thousand eight hundred and ninety-three, there shall be raised, all goods, &c. levied, collected, and paid on all articles, goods, animals, wares, and merchandise imported into *Tasmania* (with the exception of specie, tea, and sugar), a Primage Duty of One Pound per centum on the true and real value thereof as such value is defined by the said Act, and such Primage Duty shall be in addition to any Customs Duties now or hereafter payable by law on such articles, goods, animals, wares, and merchandise.

(2.) All such articles, goods, animals, wares, and merchandise as were in any bonding warehouse on and after the Twenty-seventh day of July, One thousand eight hundred and ninety-three, or as were entered to be landed on or after that day, and until the Eighth day of

September, One thousand eight hundred and ninety-three, shall be deemed to have been imported within the meaning of this Act, and shall be subject and liable to the Primage Duty hereby imposed.

(3.) The Treasurer may remit the Primage Duty hereby imposed upon any package the true and real value of which is less than the

sum of One Pound and Five Shillings.

Primage Duty of 32 per cent. on certain goods.

4 On and after the Ninth day of September, One thousand eight hundred and ninety-three, and until the Thirty-first day of December, One thousand eight hundred and ninety-four, there shall be raised, levied, collected, and paid on all articles, goods, animals, wares, and merchandise imported into the Colony (except the articles, goods, animals, wares, and merchandise set forth in the Schedule hereto), a Primage Duty of Three Pounds and Fifteen Shillings per centum on the true and real value thereof as such value is defined by the said Act, and such Primage Duty shall be in addition to any Customs Duties now or hereafter payable by law on such articles, goods, animals, wares, and merchandise.

All such articles, goods, animals, wares, and merchandise as were in any bonding warehouse on and after the Ninth day of September, One thousand eight hundred and ninety-three, or as were entered to be landed on or after that day, shall be deemed to have been imported within the meaning of this Act, and shall be subject and liable to the

Primage Duty hereby imposed.

Provided, that any articles, goods, animals, wares, and merchandise in any Bonding Warehouse on the said Ninth day of September, One thousand eight hundred and ninety-three, upon which a Primage Duty of One Pound per centum has been paid on the same being entered to be landed, a Primage Duty of Two Pounds and Fifteen Shillings per centum shall be payable instead of a Primage Duty of Three Pounds and Fifteen Shillings per centum.

Additions and Amendments to Schedule (2.) of 56 Vict. No. 16.

5 The following additions and amendments are hereby made to Schedule (2.) (Table of Duties) of the said Act; and the said Schedule (2.) as so added to and amended by this Act shall be read and construed as Schedule (2.) of the said Act; namely,-

The words "Carriages on four wheels and springs," in the fortyfirst line from the top of the first page of the said Schedule (2.) are hereby expunged, and the words "Carriages built for four wheels and springs, and whether attached to such wheels or not," are hereby inserted in lieu thereof:

The words "Carriages on two wheels and springs," in the fortysecond line from the top of the first page of the said Schedule (2.) are hereby expunged, and the words "Carriages built for two wheels and springs, and whether attached to such wheels

or not," are hereby inserted in lieu thereof:
The words "not otherwise enumerated" are hereby inserted in the twenty-first line from the top of the second page of the said Schedule (2.) after the word "canvasses":

The words "Oilskin clothing not otherwise enumerated" are hereby expunged from the thirty-first and thirty-second lines from the top of the second page of the said Schedule (2.):

The words "containing not more than ten per centum of acetic acid" are hereby inserted after the word "Vinegar," in the third line from the bottom of the fourth page of the said Schedule (2.).

#### Customs Duties Amendment.

6 The following additions and amendments are hereby made to A.D. 1893. Schedule (3.) (List of Exemptions) of the said Act; and the said Schedule (3.) as added to and amended by this Act shall be read and construed as Schedule (3.) of the said Act; namely—

Additions and Amendments to Schedule (3.) of

The words "and Canvas" are hereby inserted after the word 56 Vict. No. 16-"Jute" in the twelfth line from the bottom of the first page of the said Schedule (3.); and the words "or for sailmaking" are hereby inserted after the word "Bags" in the said lastmentioned line of the said Schedule (3.):

The words "Organs specially imported for churches or chapels" are hereby inserted between the second and third lines from

the top of the third page of the said Schedule (3.):

The following words and figures—"Rabbit-proof" and "being 2ft. 6in. to 4ft. wide, 1 to 1\frac{1}{3} inch mesh, and No. 17 or 18 gauge"—are hereby expunged from the 26th and 27th lines from the top of the third page of the said Schedule (3.):

The words, "which the Treasurer certifies should be exempt from the payment of any Custome" Duties," are hereby inserted.

the payment of any Customs' Duties," are hereby inserted after the word "Government," in the last line of the third page of the said Schedule (3.).

7 This Act and the said Act, save as far as the same is altered or Acts to be read amended by this Act, shall be read and construed together as one together.

### SCHEDULE.

Exemptions from Primage Duty at £3\frac{3}{4} per centum.

- 1. All articles, goods, wares, and merchandise mentioned and set forth in Schedule (2.) of the said Act which are subject to an ad valorem duty at the rate of Five Pounds per centum.
- 2. All articles, goods, animals, wares, and merchandise mentioned and set forth in Schedule (3.) of the said Act.
