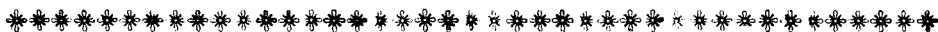

AN ACT to further amend "The City of *Hobart* A.D. 1900.
Town Loans Consolidation Act, 1880."
[6 December, 1900.]

WHEREAS it is expedient to amend "The City of *Hobart Town* PREAMBLE,
Loans Consolidation Act, 1880," in the manner hereinafter appearing:
Be it therefore enacted by His Excellency the Governor of *Tasmania*,
by and with the advice and consent of the Legislative Council and
House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited as "The City of *Hobart* Loans Act, Short title.
1900."

2 "The City of *Hobart* Loans Act, 1895," is hereby repealed. Repeal.

3 In this Act, the expression "the said Act," shall mean "The Interpretation.
City of *Hobart Town* Loans Consolidation Act, 1880." 43 Vict. No. 22.

4 Notwithstanding anything contained in the said Act, it shall not Redemption of
be obligatory on the Council to provide, in the manner directed by Debentures.
Section Fifteen of the said Act, for the redemption of any Debentures
issued under the said Act, or under any other Act which requires that
the Debentures issued thereunder shall be subject to the provisions of
the said Act, or for the redemption of any renewals of any such
Debentures as aforesaid, otherwise than in accordance with the
provisions of this Act.

Contributions to
Sinking Fund.

5 Notwithstanding anything contained in the said Act, the Council shall set apart from year to year, as contributions to the Sinking Fund, for the redemption of Debentures issued under the said Act, or under any other Act which requires that the Debentures issued thereunder shall be subject to the provisions of the said Act, not less than the sums of money hereinafter mentioned, viz. :—

i. Out of the moneys paid into "The *Hobart Water Account*," under the provisions of "The *Hobart Water Act, 1893*," a sum equal to Ten Shillings for every Hundred Pounds required for the redemption of any Debentures issued as aforesaid for the purpose of providing a supply of Water to the City of *Hobart* :

ii. Out of the moneys paid into the Municipal Fund, under the provisions of "The *Hobart Corporation Act, 1893*," a sum equal to Ten Shillings for every Hundred Pounds required for the redemption of any Debentures issued as aforesaid for any purpose than that hereinbefore mentioned :

All which sums shall be paid over to the Commissioners, and by them applied as in the manner provided by the said Act.

Ratification.

6 The provision heretofore made by the Council for the redemption of Debentures issued as aforesaid is hereby declared to be a sufficient discharge of the obligations heretofore imposed on the Council to provide for the redemption of all such Debentures.

7 All Debentures issued under "The *Hobart Water Loan Act, 1883*," shall be subject to the provisions of this Act, and shall, since the Twenty-fourth day of *October*, One thousand eight hundred and ninety-five, be deemed to have been issued subject to the provisions of the said Act.

Acts to be read
together.

8 This Act and the said Act shall be read and construed together as one Act.
