

AN ACT to enable the Mayor, Aldermen, and A.D. 1900. Citizens of the City of Launceston to borrow any Sum or Sums of Money, not exceeding £8000, for the purpose of supplying Water to the Inhabitants of the said City and other places.

[6 December, 1900.]

WHEREAS it is expedient to empower the Mayor, Aldermen, and PREAMBLE. Citizens of the City of Launceston to borrow any sum or sums of money, not exceeding Eight thousand Pounds, for the purpose of supplying Water to the inhabitants of the City of Launceston and other places, under and in accordance with the provisions of "The Launceston Water and Light Act, 1895."

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows .---

1 It shall be lawful for the Mayor, Aldermen, and Citizens of the Corporation may City of Launceston to borrow, in accordance with the provisions of borrow £8000. have paid. **3** The sum of money hereinbefore mentioned may be borrowed in addition to any sum or sums of money previously borrowed by the Mayor, Aldermen, and Citizeus of the City of *Launceston* under the authority of any former Act for the purpose of supplying water to the inhabitants of the said City and other places; and all the pro-visions of Part X. of "The Launceston Water and Light Act, 1895,"

shall be applicable to any sum or sums of money borrowed under

4 Any sum or sums of money borrowed under the authority of the provisions of this Act shall be subject to the provisions of "The City of Launceston Loans Consolidation Act, 1886," and any Act amending such last-mentioned Act.

Short title.

5 This Act may be cited as "The City of Launceston Loans Act, **19**00."
