

4. Validation of agreement.

AN ACT to authorise the Council of the Municipality of Devonport to define a Power Area within the Municipality for the purposes of Part IXA of the Local Government Act, 1906, and for other purposes.

[19 *December*, 1927.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1 This Act may be cited as "The Devonport Hydro-Electric Power Short title. Area Act, 1927."
 - 2 In this Act, unless the context otherwise indicates or requires—
 "The said agreement" means the agreement bearing date the twenty-seventh day of March, one thousand nine hundred

and twenty-four, entered into between the Honourable James Relton, Minister for Lands and Works for Tasmania (in the said agreement referred to as "the Minister," which expression, it was declared by the said agreement, should refer to the Minister for Lands and Works or other the Minister administering for the time being the State Hydro-Electric Department) of the one part, and the Warden, councillors, and electors of the Municipality of Devonport of the other part, for the purchase and supply of certain electrical energy mentioned therein, duplicate copies of which agreement are in the possession respectively of the Minister administering the said Department and the Council of the Municipality:

"The Council" means the Council of the Municipality:
"The Municipality" means the Municipality of Devonport.

Council may define power area for the purposes of Part IXA of 6 Ed VII. No. 31 (inserted therein by 14 Geo. V. No. 61), and may exercise powers conferred by the

said Part IXA.

3 It shall be lawful for the Council—

1. At any time after the commencement of this Act to define, by notice in the Gazette, any portion or portions of the Municipality to be the power area for the Municipality for the purposes of Part IXA of the Local Government Act, 1906 (inserted therein by the Local Government Act, 1924), and in like manner from time to time to alter or increase such power area: and

II. To exercise in the Municipality, in respect of such power area, all the powers and authorities conferred on the Council of a Municipality by Part IXA of the Act first above mentioned with respect to the Municipality of which such Council is

the governing body.

Validation of agreement,

4 The said agreement shall, for the purpose of Part IXA above referred to, be deemed to have been entered into subsequently to the coming into operation of that Part, and shall, notwithstanding anything to the contrary contained in such Part, be valid and binding on the respective parties thereto in the same manner and to the same extent as if it had been entered into in compliance with the provisions of the aforesaid Part
