**AN ACT to amend certain enactments in consequence of the enactment of the Tasmanian Development Act 1983.**

**[Royal Assent 20 December 1983]**

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—
