

ANALYSIS.

- 1. Short title and incorporation with 6 Geo. V. No. 66.
- 2.-(A) Remission of duty payable in respect of estate of person dying while on naval or military service.
- 3. Registrar to repay duty in certain cases.

- 5. Amendment of Schedule (2) to Principal Act, and repeal and re-enactment of Part III. of that Schedule. Saving.

AN ACT to amend certain Acts relating to the 1916. Duties on the Estates of Deceased Persons, by granting certain Exemptions with respect to the Estates of Deceased Soldiers, and by altering the Rates of Duty, and for other [23 December, 1916.] purposes.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

1-(1) This Act may be cited for all purposes as "The Deceased Short title and Persons' Estates Duties Act, 1916," and shall be deemed to be incor-incorporation porated with and be construed as one with "The Deceased Persons' 6 Geo. V. No. 66. Estates Duties Act, 1915," hereinafter called the Principal Act.

(2) The Part III. (Rates of Duty) substituted by Section Four of this Act for Part III. (Rates of Duty) of Schedule (2) to the

Principal Act shall apply only to estates of persons dying on or after the commencement of this Act, and to estates the subject of any settlement, trust, disposition, conveyance, transfer, vesting, purchase, investment, or gift made, or caused to be made, before or after the commencement of this Act by any person so dying.

2 The following Section A, shall be deemed to have been inserted:

- I. At the end of "The Deceased Persons' Estates Duties Act, 1904," prior to the repeal thereof, as from the Fifth day of August, One thousand nine hundred and fourteen, and to have been numbered therein as Section Thirty-nine:
- 11. At the end of the Principal Act, as from the commencement thereof, and to have been numbered therein as Section Fifty-six:

Remission of duty payable in respect of estate of person dying military service.

- "A Where any person dies from injuries inflicted, accident occurring, or disease contracted (within Two years before death), while on naval or military service, whether with His Majesty's navy or army or while on naval or under the provisions of any Act of the Parliament of the Commonwealth during the war in which His Majesty is at present engaged, the following provisions shall apply as to duty under this Act payable in respect of the estate of the person so dying-
 - 1. No duty shall be payable where the net present value of such estate does not exceed Three thousand Pounds:
 - II. Where such value exceeds Three thousand Pounds no duty shall be payable in respect of the First Three thousand Pounds.'

Registrar to repay duty in certain cases.

3 The Registrar upon being satisfied that any repayment of duty paid before the commencement of this Act under "The Deceased Persons' Estates Duties Act, 1904," or the Principal Act, should be made in consequence of the inclusion of Section A aforesaid in such Acts, shall order that repayment shall be made accordingly, and upon any such order being made, the State Treasurer shall pay the amount specified in such order to the person named therein, out of the Consolidated Revenue.

Extension of time for payment of duty.

- 4 The following Section is inserted after Section Thirty-six of the Principal Act:
- "36a If the Registrar is satisfied that the duty cannot be paid within the time specified in this Act, he may, upon receipt of sufficient security for payment of the duty-
 - (a) Extend the time for payment as he considers the circumstances warrant; or
- (b) Permit the payment of the duty to be made by instalments. Provided that the whole of the duty payable shall be paid within a period of One year."

Amendment of Schedule (2) to Principal Act and Repeal and re-enactment of Part III. of that Schedule,

- 5—(1) Schedule (2) to the Principal Act is hereby amended as follows:-
 - 1. By inserting at the end of the subdivision "Class II." of Part II. of the said schedule the words "Provided that the

duty so to be charged shall in no case be charged at a A D. 1916. higher rate than Ten Pounds per centum."

II By suspending the operation of Part III. (Rates of Duty) of Schedule (2) aforesaid from and after the commencement of this Act, and substituting the following, until the expiration of Two years after the termination of the said war, therefor:—

A.D. 1916. Saving. (2) The said Part III. hereby suspended shall not be deemed to be suspended so far as regards its applicability to, or in respect of, the estates of persons dying before the commencement of this Act, and estates the subject of any settlement, trust, disposition, conveyance, transfer, vesting, purchase, investment or gift made or caused to be made before the commencement of this Act by any person dying before the commencement of this Act.
