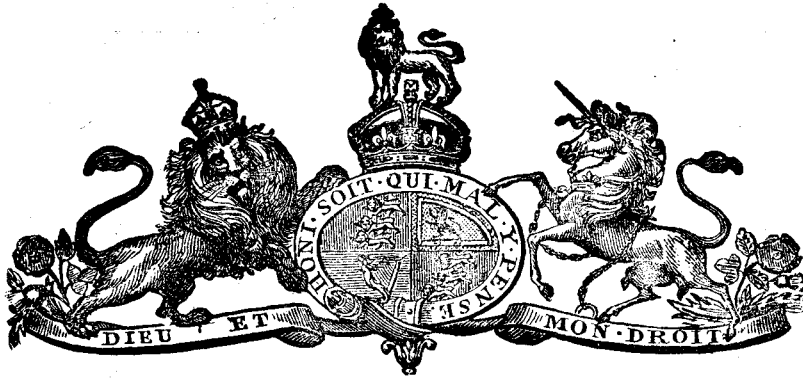

AN ACT to remove Doubts as to the Validity of the Election or Constitution of the Municipal Council of the Municipality of *Flinders Island*, and for other purposes.

A.D. 1909.

[30 December, 1909.]

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited as “The *Flinders Island* Council Validation Act, 1909,” and shall be incorporated with and read as one with “The Local Government Act, 1906,” and its amendments.

Flinders Island Validation.

A. D. 1909.

Present Council to be deemed validly elected and to hold office until successors elected or appointed.

Annual election need not be held in 1910.

Annual election, after 1910 on date proclaimed.

All councillors to retire at annual election in 1911.

Order of retirement of councillors.

Present Warden to be deemed validly elected.

Minister may make provisions to enable elections to be carried out.

Local Government Act to apply, subject to foregoing provisions.

Elections validated.

Proceedings validated.

2—(1.) It is hereby declared that the present Municipal Council of the Municipality of *Flinders Island* consists of the persons whose names as councillors are set forth in the schedule to this Act, and that they represent the wards opposite their respective names; and they shall be deemed to have been validly elected or appointed, as the case may be, and shall hold office until their successors are elected or appointed.

(2.) It shall not be necessary to hold an annual election of Councillors for the said municipality in the year One thousand nine hundred and ten.

(3.) An annual election of councillors for the said municipality shall be held in the year One thousand nine hundred and eleven, and in each succeeding year, on such day as the Minister may in each year appoint; and the Minister may, if he deems it necessary, alter any date so appointed.

(4.) At the annual election of councillors for the year One thousand nine hundred and eleven all the councillors shall retire, and the electors of each ward shall elect Three of the councillors of the municipality, and the retiring councillors shall be eligible for re-election.

(5.) For the purpose of deciding the order in which councillors shall retire after the annual election in the year One thousand nine hundred and eleven such annual election shall be deemed the election of the First Council.

(6.) The present Warden of the Municipality of *Flinders Island* shall be deemed to have been validly elected and shall hold office until his successor is chosen or appointed, and it shall not be necessary to hold an election of warden for the said municipality in the year One thousand nine hundred and ten.

(7.) The Minister may determine the date and place for any election for the said municipality, and may make such provisions as he considers desirable to enable the election to be carried out, including the appointment of any officers.

(8.) Subject to the foregoing provisions, the provisions of "The Local Government Act" shall apply.

3 All elections of councillors for the Municipality of *Flinders Island* since and including the election of the First Council of the said Municipality shall be deemed to have been regular and valid, and notwithstanding any omission to hold an annual election every councillor remaining in office, but who should have gone out of office by rotation, shall be deemed to have lawfully continued in office.

4 All acts and proceedings whatsoever (including the making or demanding of any rate, or any proceedings in relation thereto) of the Municipal Council of the Municipality of *Flinders Island*, whether as originally constituted or subsequently reconstituted, or of the local body or persons purporting to be or constitute such Council, or of any committee thereof, or of any person acting as Warden, chairman, or member of the Council or of a committee, shall be deemed to be

and are hereby declared to be as valid and legal for all purposes A.D. 1909. as if the Council, body, committee, officer, or person had been duly constituted, elected, or appointed, notwithstanding any invalidity or irregularity whatsoever; and no advantage shall be taken of any invalidity or irregularity in any action or suit brought by or against the Council or any local committee.
