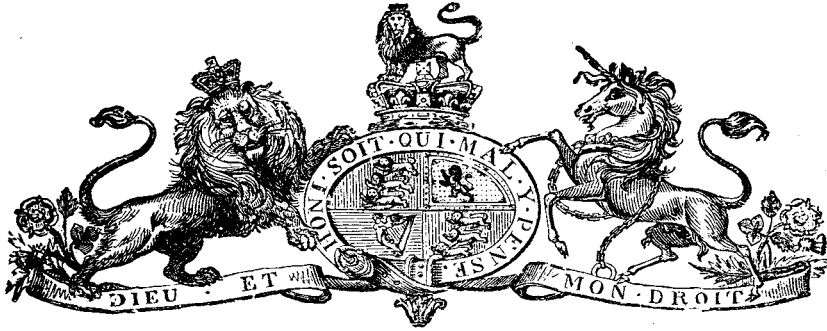

AN ACT to further amend "The *Hobart* A.D. 1896.
Corporation Act, 1893," and for the purpose
of repealing certain Acts.

[23 October, 1896.]

WHEREAS it is expedient to further amend "The *Hobart* PREAMBLE.
Corporation Act, 1893," in the manner hereinafter appearing, and to repeal
the several Acts and parts of Acts mentioned in the Schedule:

Be it therefore enacted by His Excellency the Governor of *Tasmania*,
by and with the advice and consent of the Legislative Council and
House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as "The *Hobart* Corporation Act, 1896." Short title.

2 In the interpretation and construction of this Act the words Interpretation.
"the said Act" shall mean "The *Hobart* Corporation Act, 1893."

3 The word "Six" is hereby substituted for the word "Five" in the Hours of polling.
fifth line of the Thirtieth Section of the said Act, and the voting at
every election hereafter held under the said Act shall commence at Nine
o'clock in the forenoon and shall finally close at Six o'clock in the after-
noon of the same day, unless adjourned by reason of riot or interruption
as in the said Act provided.

Citizens who are owners of property may vote in respect thereof.

4 Every Citizen whose name is on the Assessment Roll as the owner of any land or building therein mentioned shall have a number of votes proportionate to the annual value of such land or building according to the scale set forth in Section Twenty-four of the said Act, in the same manner and to the same extent as if the name of such Citizen appeared in the Assessment Roll as the occupier of such land or building.

Repeal.

5 The several Acts mentioned in the Schedule hereto are hereby repealed to the extent to which they are therein respectively declared to be repealed ; but such repeal shall not affect anything heretofore lawfully done under any of the said several Acts, or any penalty or liability or right incurred or acquired under any of them.
