

## AN ACT to further amend The Licensing Act. [21 December, 1871.]

WHEREAS it is expedient to further amend The Licensing Act: PREAMBLE. Be it therefore enacted by His Excellency the Governor of Tasmania, 21 Vict. No. 39. by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 It shall be lawful for any Two Justices, in Petty Session assembled, Permissions to in any District in which any house or room at or on any Railway sell Liquor at Station is situate, on payment of the fee payable in that behalf as Railway Stations. hereinafter provided, to grant permission to the holder of a Publichouse Licence in respect of a house situate within such District, to sell Liquor within any house or room at or on any Railway Station within such District during the hours within which trains run upon the Railway; and every such permission shall have effect during the continuance of the Public-house Licence of the holder thereof to whom such permission is granted, and no longer; and any Two Justices so assembled shall also have power, on payment of the proper fee, to renew any such permission, or on payment of the fee payable in that behalf as hereinafter provided, to grant a Certificate endorsed thereon, approving of the transfer of any such permission to any other person, and all such fees as aforesaid shall be paid into the Colonial Treasury and form part of the General Revenue.

2 The sums mentioned in the Schedule (1) shall respectively be Fees. payable and paid to the Clerk of Petty Sessions of each District in respect of the matters in the said Schedule in that behalf mentioned.

#### Licensing Amendment Act, No. 5.

Licensing Meeting at Hobart
Town or Launceston may grant
permission to sell
at every Railway
Station on Line
of Railway having
a Terminus at

3 Notwithstanding anything hereinbefore contained, it shall be lawful for any Licensing Meeting held at Hobart Town or Launceston, on payment of the fee payable in that behalf as hereinafter provided, to grant permission to the holder of a Public-house Licence in respect of a house situate within Hobart Town or Launceston, as the case may be, to sell Liquor within any house or room at or on every Station upon any Line of Railway which has a Terminus at either Hobart Town or Launceston; and all the provisions of the First Section of this Act with respect to the continuance of any permission named therein, and to the renewal of any such permission and any transfer of the same, shall apply and extend to any permission granted under this Section, save that the sums mentioned in the Schedule (2) shall respectively be payable and paid to the Clerk of the Peace at Hobart Town or Launceston, as the case may be, in respect of the matters in the said Schedule (2) in that behalf mentioned.

Permission not to be granted without consent of Directors of Railway Company, No permission untile this Act, not any renewal or transfer thereof, shall be granted by any Licensing Meeting or Justices unless the applicant shall produce to such Meeting or Justices the consent and approval in writing of the Board of Directors or other person for the time being having the control and regulation of the Railway in respect of which such permission or any renewal or transfer thereof may be sought.

Acts to be read together.

5 This Act and The Licensing Act, and any Act altering or amending the same, shall, save as altered or amended by this Act, be read and construed together as one Act.

Short Title.

6 This Act may be cited as "The Licensing Amendment Act, No. 5."

# SCHEDULE.

## (1.)

For every Permission to sell Liquor at any Railway Station, and for every renewal thereof, the sum of One Pound.

For every Certificate approving of the transfer of any such Permission as aforesaid the sum of Ten Shillings.

(2.)

For every Permission to sell, Liquor at every Railway Station, and for every renewal thereof, the sum of Five Pounds.

For every Certificate approving of the Transfer of any such Permission as aforesaid the sum of Two Pounds and Ten Shillings.
